**State of Punjab Vs. Gurjinder Singh**

1. Heard on application under Section 319 Cr.P.C for summoning the additional accused namely Pritpal Singh s/o Sadhu Singh, Preet Kamal d/o Pritpal Singh and Kiranpreet Kaur d/o Pritpal Singh all residents of Model Town, Uttam Nagar, Batala and through the application, prosecution is seeking such summoning with submission in brief that complainant Rajinder Kaur had moved application against present accused Gurjinder Singh, her husband alongwith other named Pritpal Singh (father-in-law of complainant), Preet Kamal and Kiranpreet Kaur (both sisters-in-law of complainant) requesting for registering the FIR against them also apart from the accused Gurjinder Singh, but due to political pressure, police did nothing against them. Adding further that while appearing as witness box as PW-1, Rajinder Kaur complainant has stated about participation of these three persons along-with accused Gurjinder Singh, prayer was made such summoning.

2. *Albeit* there was no requirement for calling reply of the accused Gurjinder Singh, but it was called by Ld. Predecessor of this Court, wherein accused denied involvement of above three persons as well as his own involvement in commission of any offence.

3. The Court has heard rival arguments and file was perused. It was clear from such perusal that not only while appearing into the witness box as PW-1, but *ab-initio*, the complainant Rajinder Kaur has named above three persons i.e. her father-in-law and sisters-in-law to subject her to cruelty on account of dowry demand followed by misappropriation her belonging on the part of all four persons. Making it clear that plea of present accused Gurjinder Singh of false implication is matter of trial, considering on oath version of complainant Rajinder Kaur, as PW-1 coupled with contents of the Challan and documents annexed with it, the Court is satisfied about the fact of apparent involvement of the above named three persons i.e. Pritpal Singh s/o Sadhu Singh, Preet Kamal d/o Pritpal Singh and Kiranpreet Kaur d/o Pritpal Singh in subjecting the complainant to cruelty on account of dowry demand as well as to misappropriate her dowry article/ISTRI DHAN and other belongings.

4. Further, the approach of police was not good, as the police directly concluded about innocence of these persons without showing/bringing some cogent reasoning of such conclusion. Hence, in view of the above discussion, the present application is disposed off being allowed and the above named persons Pritpal Singh s/o Sadhu Singh, Preet Kamal d/o Pritpal Singh and Kiranpreet Kaur d/o Pritpal Singh are ordered to be summoned as additional accused to stand trial along-with present accused Gurjinder Singh for committing offence punishable under Section 498-A, 406 of IPC for 02.04.2026.
