In compliance of the order dated 10.11.2025 passed by this court, application of accused Navpreet Singh @ Nav has not been forwarded by the concerned Jail Superintendent to this court. The concerned Jail Superintendent is again directed to collect his application and forwarded the same to this court on the next date of hearing.

Report from the Superintendent of the concerned jail qua medical condition of accused Gurwinder Singh @ Baba, has not been received. Same be again called for the next date of hearing, as per previous order.

PW Kumar Vansh is present, who has been examined as PW-47.

Bailable warrants issued qua PW ASI Paramjit Singh has been received back served through concerned police station but he has not come present. Bailable warrants issued qua PW Gurbhej Singh has been received back with the report that warrants sent to concerned police station. Summons issued to PW ASI Balraj Singh has been received back with a report that he is already bound down for today. Summons issued to PW Satwinder Singh has been received back with a written request that he is unable to attend the court as he is suffering from backbone issue and has requested that his statement may be recorded through video conferencing. The request is hereby allowed and he is directed to appear through video conferencing, as per video conferencing rules for deposing in the present case on the next date of hearing.

Arguments on the application moved by Sh. HPS Ishar Advocate, learned counsel for accused Gurwinder Singh @ Baba under sections 269, 349 and 350 BNSS, 2023 for issuing directions to the prosecution to physically produce accused Gurwinder Singh @ Baba (who is confined in Central Jail, Kapurthala), in court for recording of evidence, not advanced.

The matter is adjourned to **12.01.2026** for prosecution evidence. PW-20 ASI Paramjit Singh and PW Gurbhej Singh be again summoned throughailable warrants in the sum of Rs.2,000/- with one surety in the like amount each for the date fixed. PW ASI Balraj Singh be again summoned for the date fixed. Arguments on the aforesaid application be also advanced on the date fixed.

For completion of the trial in a time bound manner, CIO of this case is directed to appear in person to assist the court for framing schedule for examining the witness in block dates.
