JUDGMENT

(Delivered on 04th day of November, 2023)

This is an Inventory Proceeding filed upon the death of late Vaman Khalu Thakur Gaonkar @ Vaman R. Thakur @ Vaman Ravlu Thakur @ Vamona Roulu Tacur, Mahalaxmi Vaman Thakur @ Malcumim Tacur @ Malcumi Tacur, both formal residents of Deulwada, Arambol, Pernem Goa, and Prema Tacur @ Prema Thakur @ Damayanti Sadanand Satoskar, daughter of late Vaman R. Thakur, formal resident of Junaswada, Mandrem, Pernem Goa.

2. The Proceedings are filed by the Applicant who is the son of deceased no.1 and 2 and brother of deceased no. 3, for partition/allotment of the estate left by the deceased/estate leavers late Vaman Khalu Thakur Gaonkar @ Vaman R. Thakur @ Vaman Ravlu Thakur @ Vamona Roulu Tacur, Mahalaxmi Vaman Thakur @ Malcumim Tacur @ Malcumi Tacur, and Prema Tacur @ Prema Thakur @ Damayanti Sadanand Satoskar, daughter of late Vaman R. Thakur. By Order dated 15.11.2022 passed on Exhibit B-1, applicant was appointed as Head of the Family. Oath was administered to the Head of the Family.

3. The Affidavit/Statement on Oath (at Exhibit C-5) of the Head of the Family was filed wherein he stated that Vaman Khalu Thakur Gaonkar @ Vaman R. Thakur @ Vaman Ravlu Thakur @ Vamona Roulu Tacur expired on 21.01.1983 at Deulwada, Arambol, Pernem-Goa, and Mahalaxmi Vaman Thakur @ Malcumim Tacur @ Malcumi Tacur expired on 28.12.1986 at Deulwada, Arambol, Pernem Goa, leaving behind deceased no. 3 and the Head of the Family/Interested Party

married to Mrs. Mangala Soropo @ Bhavana Ullas Tacur, as their sole and universal heirs.

4. Deceased no. 3 Prema Tacur @ Prema Thakur @ Damayanti Sadanand Satoskar expired on 12.02.2019 at Junaswada, Mandrem, Pernem Goa, leaving behind her husband Mr. Sahadeu Nausso Satoskar and her children namely Mrs. Pusha Sahadeo Satoskar @ Priyanka Prakash Sawant married to Prakash Anant Sawant, Anil Sadanand Satoskar married to Lata Mahadev Shetye @ Anita Satoskar, Mr. Deepak Satoskar married to Mrs. Deepti Deepak Satoskar @ Sampada Sharad Thakur and Mrs. Chandrakala Sadanand Satoskar @ Chandrakala Ladu Sawant married to Ladu Raghuvir Sawant.

5. In the above stated manner the deceased no. 1 to 3 expired without any Will or other disposition of their last wish, leaving behind them the Head of the Family/ Interested Party as their sole and universal heirs.

6. This statement is not contested by the Interested Party. The legal heirs of deceased no. 3 executed Deed of Relinquishment

relinquishing their rights/share in the estate of deceased no. 3 in favour of the other legal heirs.

7. The Applicant/Head of the Family has produced death certificates of Vaman Thakur, Mahalaxmi Thakur and Prema Thakur (deceased no. 1 to 3), and birth/marriage certificates of the Head of the Family/ Interested Party and the legal heirs of deceased no. 3. Head of the family has also produced on record copy of Deed of Relinquishment dated 05.08.2023 and the translated copy of title document.

8. I have perused the statement of the Head of the Family and the documents produced by him.

9. In view of No Objection to the Initial List of Assets at Exhibit C-6, Final List of Assets was drawn at Exhibit C-8. Scheme of Partition came to be filed at Exhibit C-12. In view of no objection to the provisional Chart of Allotment at Exhibit C-13, Final Chart of Allotment came to be drawn at **Exhibit C-14**. The stamp duty as mandated under Section 455 of the Goa Succession, Special Notaries Act, 2012 is paid.

10. In view of the case set out and the procedure followed, allotment as per the Final Chart of Partition dated 19.08.2023, at **Exhibit C-14**, stands confirmed.

11. Decree to be drawn accordingly.
