C H A R G E

I, Bharath Yogeesh Karagudari, BAL., LLM, Prl. Civil Judge & JMFC, Pavagada, do hereby charge on you : -

1. That on 15.05.2015 at about 08-00 pm in the house of accused at Kothuru village, Pavagada Taluk within the jurisdiction of Arasikere police station, with an intention to commit offence you accused No. 1 to 3 picked up quarrel with CW1 and abused her in filthy language and gave provocation which itself is likely to causes breach of public peace, thereby you accused committed offence Punishable under section 504 read with 34 of Indian Penal Code and within the cognizance of this court.

2. On the above said date, time and place, accused picked up quarrel with CW1 and accused No.2 assaulted CW1 with hands on her back and huckle and caused bodily pain to her. Thereby accused No.2 committed

offence Punishable under section 323 read with 34 of Indian Penal Code and within the cognizance of this court.

3. On the above said date, time and place, picked up quarrel with him, accused No.3 assaulted CW1 with club on her butts and legs and caused simple injury. Thereby accused No.3 committed offence Punishable under section 324 read with 34 of Indian Penal Code and within the cognizance of this court.

4. On the above said date, time and place you accused No.2 obstructed CW.1 with an intention of committing offence, stopped the CW1, without allowing to proceed in any direction and confined her, thereby you accused No.2 committed an offence punishable under section 341 read with 34 of Indian Penal Code and within the cognizance of this Court.

5. On the above said date, time and place, the accused No.2 and 3 gave threat to the life of CW1, thereby committed criminal intimidation. Thereby accused No.2 and 3 committed offence Punishable under section 506 read with 34 of Indian Penal Code and within the cognizance of this court.

And I hereby direct that you be tried by this court on the above said charge.
