Brief facts of the petition:

The claim arises out of an accident caused by the vehicle bearing owner of Santro Car bearing No.TS28L-0731 owned by the 2nd respondent. The police registered case in Cr.No.16/2022, U/sec.304(A) of A.Konduru P.S.

The petition is coming on for final settlement in the presence of petitioner and the respondent and Sri K.V.V.SURYANARAYANA REDDY, Advocate for the petitioners and Sri B.SAMBHU PRASAD, Advocate for the 3rd respondent are present before the Lok Adalat. Both parties to the petition have agreed for amicable settlement with free will and volition. Hence, the following award is passed as per the settlement arrived by the parties.

AWARD UNDER SEC.21 OF THE LEGAL SERVICES AUTHORITIES ACT, 1987

1. After negotiations and conciliation between the parties the claim of petitioners is settled at Rs. 71,50,000/- (Rupees seventy one Lakhs Fifty thousand only) without interest and costs and award is passed accordingly. If the 3rd respondent does not deposit the above amount within one month from today amount so awarded shall carry interest at 6% per annum from the date of award. The Court fee, if paid shall be refunded.

2. APPORTIONMENT OF THE AMOUNT AWARDED:

- 2 Rs. 2,00,000/-
- 3 Rs. 2,00,000/-
- 4 Rs. 2,00,000/-

The balance amount shall be deposited separately in any Nationalized Bank / Scheduled Bank for a period of ONE YEAR or till the minors attains majority which ever is later. After that the petitioners are permitted to withdraw the same.

In case of urgent necessity, the petitioner is at liberty to approach the Tribunal for further withdrawal. Accordingly award is passed without prejudice to the rights and contentions of the driver and owner of the crime vehicle
