Accused Sarup Singh, Sukhwinder Singh, Vishaldeep Singh, Lovepreet Singh and Shakil produced in Court by jail authorities. Accused Sehajpreet Singh, Amarjit Singh, Karanbir Singh, Sharanjeet Singh and Gurpreet Singh produced by jail authorities through VC. Accused be again produced through VC on 23.12.2025.

Vide my separate detailed order of even date application for filed by accused Sehajpreet Singh for discharge stands dismissed.

Ms.Manveet Kaur Advocate has received copy of challan today in the Court vide her separate statement to this effect.

DSP Rajan Parminder Singh has appeared and suffered the following statement:

"Stated that the investigating agency had applied for seeking the sanction to prosecute the accused under UAPA Act and the sanctioning authority has not granted sanction till date and the said process is in progress.

The sanction will be submitted in the Court as and when the same is granted by the concerned sanctioning authority."

As per the statement of DSP the sanction to prosecute under UAPA Act has not been submitted on the record since the sanction is not there. As such, at this stage the charge under UAPA Act cannot be framed. However, the prosecution is at liberty to submit the sanction on the later stage.

Heard on the question of framing of charge. The allegations against accused/applicants are that on 21.10.2023 SI Amandeep Verma with his police party and he received secret information that accused had involved in terrorist activities in the State of Punjab and they are about to cause life threat to religious , political and other personalities of the state and thereafter the accused were apprehended and from their possession arms and ammunition were recovered.

I have gone through the report submitted by the Police under Section 173 Cr.P.C. and the documents placed on the file and found that a prima-facie case under Section 120-B and 121 IPC, Section 25 of Arms Act, Section 21 NPDS Act and Section 3,4 and 5 of Explosive Act are made out against the accused-persons and charge for the same has been framed against the accused persons to which they did not plead guilty and claimed trial.

Let, prosecution witnesses mentioned at S.No. 4,5,6,7 and 9 be summoned for **23.12.2025** through office of District Attorney, SAS Nagar Mohali as well as through office of SSP, Mohali.

Scanned Copy of the chargesheet be sent to the Superintendent of concerned jail where accused Sehajpreet Singh, Amarjit Singh, Karanbir Singh, Sharanjit Siingh and Gurpreet Singh are lodged and they are directed to get it signed from the concerned accused and remit it back to this Court before the date fixed through email or speed post.
