Brief Facts of the Petition:

This claim arises out of an accident caused by the Lorry bearing No.AP-16-TS-6406 owned by the 2nd respondent and insured with the 3rd respondent.

This petition is coming on for final settlement in the presence of petitioners and the Respondent and **Sri.P.R.R.**, Advocate for the petitioner and **Sri.Md.Sharif.**, Advocate for the 3rd respondent are present before the Lok Adalat. Both parties to the petition have agreed for amicable settlement with free will and volition. Hence, the following Award is passed as per the settlement arrived by the parties.

AWARD UNDER SEC.21 OF THE LEGAL SERVICES AUTHORITIES ACT.

After negotiations and conciliation between the parties the claim of the petitioners is settled at **Rs.8,90,000/- (Rupees Eight Lakhs Ninety Thousand Only)** without interest and costs and an award is passed accordingly. If the 3rd respondent does not deposit the above amount within one month from today amount so awarded shall carry interest at 6% per annum from the date of award. The court fee, if paid shall be refunded.

APPORTIONMENT OF AMOUNT AWARDED:

In case of urgent necessity, the petitioner/s is/are at liberty to approach the Tribunal for withdrawal of further amount subject to filing necessary proof.

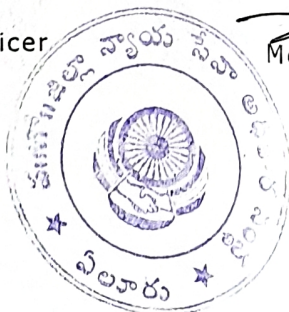
