as follows:

That on 24-03-2019 at about 11-15 P.M., the CW-1 to CW-5 were proceeding in the vehicle which is belongs to CW-14 i.e., the Bolero sheep pickup vehicle bearing Reg:No.KA-13-B-3524, you accused No.1 was driving said vehicle. The CW-1 to 5 were having amount for purchasing sheeps with them during travel you accused no.1 knowing that had intimated you accused no.2 to 7 and all of you had pre planned to commit robbery from CW-1 to CW-5. As pre planned by you all accused persons, you accused no. 2 to 7 followed the vehicle which was driving by the accused no.1 in a vehicle Chaverlet Thavera bearing Reg.No.KA-02-EA-3029 and dashed to the Bulero Pickup vehicle, restrained the vehicle, hit the glass with eggs, the accused no.1 as pre-planned earlier slow down the vehicle, accused no.5 pushed the Bulero vehicle to side of the road with the vehicle he was driving, accused no.1 stopped the vehicle and committed criminal conspiracy to commit robbery and thereby committed an offence punishable U/Sec.120(B) of IPC within the cognizance of this court of sessions?

2) Secondly, on the above said date, time and place, among you accused no.2 to 7 as pre-planned earlier by you accused no.1, you accused No.5 snatched the mobile from accused no.1 and CW-5. You accused no.2, 3, 6 and 7 entered inside the

Bulero pick up vehicle with chilli power and knife, poured the chilli power on the persons sleeping in the vehicle and shown the knife deadly weapon to the said persons demanding money. As CW-1 to CW-4 slow down to pay the amount, you accused no.2 stabbed to CW-1 on his arm and caused blood injury, you accused no. 3 stabbed right leg of CW-1 and caused blood injury and robbed Rs.50,000/- from CW-1 and Rs.79,750/- from CW-2 and thereby committed the offence punishable U/Sec.397 of IPC within the cognizance of this court of sessions?

3) Thirdly, on the above said date, time and place, you accused no.1 to 7 conjointly, among you accused no.1 to 7, you accused no. 1 robbed the mobile from CW-5, robbed Rs. 50,000/- from CW-1 and Rs. 79,750/- from CW-2 and thereby committed offences punishable U/Sec. 395 of IPC within the cognizance of this court of sessions?

4) Lastly, on the above said date, time and place, among you accused no.1 to 7, you accused no.4 with an intention to cause disappearance of evidence , thrown away the knife which were used to assault CW-1 and cleaned the chilli powder which was fell on the floor and thereby committed an offence punishable U/Sec. 201 of IPC within the cognizance of this court of sessions?

I hereby direct that, you be tried by this court on the above said charges.
