**CHARGE**

I, U. C. Deshkumkh, NDPS Special Judge (Under NDPS Act, 1985) for Greater Bombay, do hereby charge you accused no.1 **Akshay Ramu Medithi** and no.2 **Karan Sundeep Mehra** as follows:-

**FIRSTLY:-** That you abovenamed accused on 05/04/2024 were found involved in importing 214 grams of Ganja/Marijuana, a contraband, concealed in one courier parcel tracking no.EE224566864CA dispatched from Canada and thereby you have committed an offence under section 8(c) punishable under section 22(a) of the NDPS Act, 1985 and within the cognizance of this Court.

**SECONDLY:-** That, on 08/04/2024 in search of residential premises i.e. Building no.38, 'A' Wing, Flat no.302, Manish Nagar, 4

Bungalow, Andheri West, Mumbai – 54 of you accused No.1 viz. **Akshay Ramu Medithi** was found in possession of 6.36 grams of Charas/Hashish and thereby you accused no.1 have committed an offence under Section 8(c) r/w punishable under Sections 20(b)(ii)(A) of the NDPS Act, 1985 and within cognizance of this Court.

**THIRDLY:-** That, further on 08/04/2024 in search of residential premises i.e. Building no.38, 'A' Wing, Flat no.302, Manish Nagar, 4 Bungalow, Andheri West, Mumbai – 54 of you accused No.1 viz. **Akshay Ramu Medithi** was found in possession of 0.74 grams printed paper having squared shape grids purported to be LSD and thereby you have committed an offence under Section 8(c) r/w punishable under Sections 20 (b)(ii)(C) of the NDPS Act, 1985 and within cognizance of this Court.

**FOURTHLY:-** That, you abovenamed both accused no.1 and 2 on the aforesaid date and place illegally imported 240 grams of Ganja into India by courier and 6.36 grams of Charas/Hashish was found in the residential premises of you accused no.1 and thereby you have committed an offence under section 8(c) punishable under section 23(a) of NDPS Act, 1985 and within the cognizance of this Court.

**FIFTHLY :-** That, you abovenamed accused no.1 on the aforesaid date on search of your residential premises found with 0.74 grams printed paper having squared shape grids purported to be LSD and thereby you have committed an offence under section 8(c) punishable under section 23(c) of NDPS Act, 1985 and within the cognizance of this Court.

**SIXTHLY :-** That, you accused no.1 **Akshay Ramu Medithi** during the aforesaid period arranged, financed and assisted the other co-accused to smuggle Ganja and other contraband into India and thereby you have committed an offence under section 8(c) punishable under section 27A of NDPS Act, 1985 and within the cognizance of this Court.

**SEVENTHLY :-** That, you accused no. 2 **Karan Sundeep Mehra** during the aforesaid period, provided your KYC documents to accused no.1 **Akshay Ramu Medithi** for importing Ganja/Marijuana in India in small quantity of Ganja/Marijuana for personal consumption and thereby you have committed an offence under section 8(c) punishable under section 27 of NDPS Act, 1985 and within the cognizance of this Court.

**EIGHTHLY :-** That, you abovenamed both the accused no.1 and 2 on the aforesaid date, time and place were a party to a criminal conspiracy to commit an offence i.e. to possess, procure, sell, transport, import and abetted the illicit trafficking of Ganja/Marijuana, Charas/Hashish and LSD papers into India and thereby you have committed an offence punishable under section 8(c) r/w sections 29 of the NDPS Act and within the cognizance of this Court.

And I hereby direct you to be tried for the said charge by this Court.
