3. On 15.12.2022, Initial list of assets stating its valuation is filed at Exh C-10. All the interested parties have endorsed their No objection to the initial list of assets and valuation. Since the said initial list of assets and valuation was not disputed, therefore final list of assets is filed was filed at Exbt. A-11.

4. On 16.12.2022 Scheme of partition was filed at Exbt. A-14, wherein no objection was endorsed on behalf of all the interested

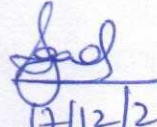
