**Suit Claim:-**

The plaintiff most respectfully prays that the Hon'ble court pleased to pass the judgment and decree in his favour and against the defendant as follows.

1. By directing the defendants to pay the loan amount of Rs. 57,930.44/- (Fifty Seven Thousand Nine Hundred and Thirty Rupees Forty Four Paise Only) (subject to variation) interest calculated up to 30.07.2022 future interest is to be added from 31.07.2022. and interest there on at the rate of @ 14.35% P.a. from the date of filling the suit till the date of realization in a single installment.

2. Direct the defendants to pay the Decree amount within the time stipulated by this Hon'ble court by drawing the decree.
3. For creation of charge over the hypothecated Stocks of the defendant.
4. In case if the proceeds of the sale are found to be insufficient to pay the amount due to the plaintiff, then that liberty be reserved to the Plaintiff to apply for balance amount from defendant as personal decree.
5. For recovery of court costs and such other relief as this Hon'ble court deems fit to grant under the circumstances of this suit in the interest of justice and equity.

This suit is coming for final disposal on 09<sup>th</sup> day of January 2023, before Smt. Pameela M., B.Com., LLB., Addl. Senior Civil Judge and JMFC., Channarayapatna in presence of Sri. K.B.K. advocate for the Plaintiff and Defendant is placed Exparte. After contest and by pronouncing the Judgment.

**ORDER**

***It is ordered and decreed that, suit of plaintiff bank is decreed with costs.***

***The defendants has to pay amount of Rs. 57,930.44/- with interest at the rate of 6% per annum on principal sum from the date of filing of this suit till it realization.***
