Cross Examination of PW- 1 by Sri.R.V.B Advocate.

1. I have two son. They both are major. The elder one is employed at Mumbai on Temporary Bases. My second son is unemployed and he is with me. He is 22 years old. He is 11th fail. Is your second son mentally and physically fit was the question posted ? The answer of the witness is he is under tension.

2. I leave with my husband for 25 years after our marriage. During my matrimonial life with my husband for 25 long years I never complained against him before any court of law or before any police station. With regard to the physical or mental harassment as you alleged against this respondent in this petition orally you does not possess any documents with regard to it. Witness says she possess such documents supporting her allegations.

3. In support of the above allegations my neighbors are my witnesses. The neighbors of Puna is my witnesses. I will examine then as my witnesses. Now I cant remember the names of those witnesses.

We had a 25 long marital life at Puna. My children pursued their education at Puna.

4. At the time of our marriage respondent was working in a Hotel. After marriage we were residing at Bosidi, Puna in rented House. It is true that my husband brothers were residing with us when we were at Puna. It is false to suggest that I ousted brother of respondent from our house. It is false to suggest that brother of the respondent started to he reside separately after our wedding.

5. It is false to suggest that I had habit of going to movies and having my supers at Restaurant and shopping at shopping malls. I do not know that my husband had megar salary of Rs.8000/- per month and he never told me about it. It is false to suggest that as respondent was earning very less he was unable to meet my lavish life style.

6. My husband had studies only till SSLC. My first delivery in the year 1994 was at Karwar. It is false to suggest that after my first delivery we went to Puna and I started to demand my husband to avail a bigger house . It is false to suggest that after we going to Puna after my first delivery my husband has shifted out resident to Khotrud Puna. It is false to suggest that we shifted to Keshav Nagar Puna .

7. In our long 25 years of matrimonial life we resided at Bosadi and Hadapsor. We stayed for 8 years at Bosadi and rest of our life at Hadapsor.

I don't know the distance between Bosadi and Hadapsor but if we travel it takes surround two and half hours to reach destination. After our marriage we both resided at Karwar for one month. It is false to suggest that on my compulsion me and respondent resided at Karwar.

8. It is false to suggest that my husband had left job at Puna and he started work at Karwar in Oil Company. It is false to suggest that as the salary was very megar in Oil company resp went back to Puna to join the Hotel. It is true that when my husband went back to Puna a resided at Karwar only. I did not accompany him.

9. It is false to suggest that my husband was sending money by working at Puna . It is false to suggest that all of a sudden I return to Puna accompany him. Respondent purchased a residential house at Puna but it was not on my instigation. The purchased house was a old house. The said house was purchased by availing loan.

10. It is false to suggest that as my husband salary was very me-gar I used to tour-char him.
