hereby charge you:

That on 17/11/2020 at 07.15 P.M., in Hotegaali Village,
Karwar in your shop you accused were found in possession of
750 ML Royal Stag Whiskey 12 bottles, 750 ML Mcdowelled
No.1 Whiskey 04 bottles, 750 ML No.1 Blenders pride Whiskey
01 bottle, 750 ML Goa's Special Palm Fenny 15 bottles, 750
ML Real Whiskey 15 bottles, 750 ML Light Horse Whiskey 2
bottles, 500 ML King Fisher Draught beer 14 Tins and 500 ML
King Fisher Strong beer 14 tins exceeding the quantity

prescribed and found selling the same in contravention of law and without having any license or permit and thereby you have committed an offence punishable U/sec. 32 of Karnataka Excise Act within my cognizance?

2) Secondly, on the aforesaid date, time and place, your accused were found in possession of intoxicants as stated above without lawful authority knowing the same to have been unlawfully collected or knowing the prescribed duty not to have been paid thereon and thereby you accused have committed an offence punishable U/Sec. 34 of Karnataka Excise Act and within my cognizance?

3) Thirdly, on the aforesaid said date, time and place you found in possession the above said liquor in your shop and thereby you have committed an offence punishable U/Sec.38(A) of Karnataka Excise Act within my cognizance?

And I hereby directed you to be tried on the above said offence.
