Charge sheet copies are supplied to pleader of the accused No. 3 and 4 as per section 230 of BNSS.

Plea is recorded, ready over and explained to learned Counsel Sri MTN on behalf of accused No.3 and 4 .

Ld. Counsel Sri MTN pleaded guilty on behalf of accused No.3 and 4.

Hence, in view of plead guilty, I proceed to pass the following;

ORDER

Acting u/sec. 264 of BNSS of 2023 the accused No.3 and 4 are hereby convicted for the offence punishable u/sec. 194(2) of BNS-2023.

Accused No.3 and 4 are sentenced to pay fine amount of Rs.300/-each.

In default of payment of fine amount accused No.3 and 4 shall undergo simple imprisonment for 15 days.

Office is directed to collect the fine amount.

Accused No.1 and 2 absent.

Ld. Counsel Sri BNN filed vakalath on behalf of accused No. 1 and 2 and filed application U/s. 276

of BNSS and submits that accused No.1 and 2 are going to plead guilty in their absence for the offence punishable u/sec. 194(2) of BNS-2023.

Charge sheet copies are supplied to pleader of the accused No. 1 and 2 as per section 230 of BNSS.

Plea is recorded, read over and explained to learned Counsel Sri BNN on behalf of accused No.1 and 2 .

Ld. Counsel Sri BNN pleaded guilty on behalf of accused No.1 and 2.

Hence, in view of plead guilty, I proceed to pass the following;

ORDER

Acting u/sec. 264 of BNSS of 2023 the accused No.1 and 2 are hereby convicted for the offence punishable u/sec. 194(2) of BNS-2023.

Accused No.1 and 2 are sentenced to pay fine amount of Rs.300/- each for the offence punishable u/sec. 194(2) of BNS-2023.

In default of payment of fine amount accused No.1 and 2 shall undergo simple imprisonment for 15 days.

Office is directed to collect the fine amount and refer the matter to Lok Adalath.
