It is further ordered and decreed that, the defendant is hereby liable to repay the loan amount of Rs.5,40,354.36 (Rupees Five Lakh Forty Thousand Three Hundred Fifty four and Thirty Six Paise only) with interest at 13.50% p.a, from the date of suit, till the date of decree.

It is further ordered and decreed that, the defendant is hereby directed to repay the loan amount of Rs.5,40,354.36 (Rupees Five Lakh Forty Thousand Three Hundred Fifty four and Thirty Six Paise only) to the plaintiff-Bank with interest at 13.50% p.a, within 45 days from today.

In default, the defendant is liable to repay the above said amount with additional interest at 1% p.a, till realization of amount.

And it is further ordered and decreed that defendant is do pay to the plaintiff-Bank a sum of Rs.35,804/- (Rupees Thirty Five thousand Eight hundred Four) only being the cost of this suit.
