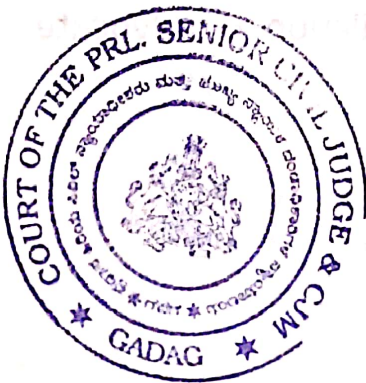
**It is ordered and decreed that:**

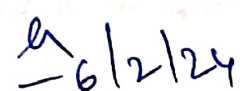
**ORDER**

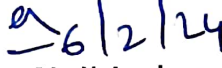

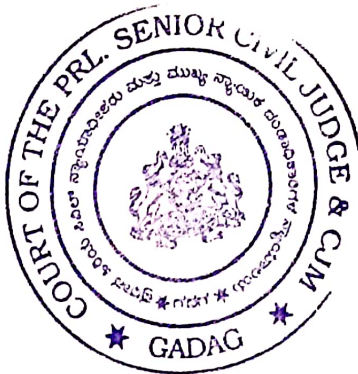

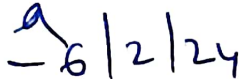
