The learned A.P.P. has orally objected to said bail application.

ORDER ON BAIL APPLICATION
UNDER SECTION 480 OF
BNSS., FILED ON BEHALF OF
THE ACCUSED PERSON

This bail application is filed by the counsel for the accused person U/Sec.480 of BNSS., for the offences punishable U/Sections 2(16), 2(20) Sec. 9, 39, 48(A) and 51 of Wild Life Protection Act. Further it is contended that, the accused person is not committed any offences as alleged by the concerned P.S. and accused person is belongs to respectable family. Further, counsel for the accused person submitted that the accused person is ready to obey any conditions impose by this court. Hence, prays to allow the said application.

Heard both side counsels.

The counsel for accused person has filed a copy of the bail

order passed by Hon'ble District and Session Judge, Uttara Kannada, in Crl. Misc. Petition No. 442/2025 in respect of accused person.

On perusal of the above order, it is clear that the Hon'ble District and Session Judge, Uttara Kannada, has granted anticipatory Bail to the accused person subject to the conditions enumerated in the order. Hence, when the Hon'ble court has already granted anticipatory bail, reconsidering the bail application on merits does not arise. Therefore, the bail application filed by the accused person deserves to be allowed. Accordingly, this court proceed to pass the following

ORDER

The application filed by the counsel for the accused person U/Sec.480 of BNSS., is hereby allowed.

The accused person is enlarged on bail by executing personal bond sum of Rs.1,00,000/- with one surety for the like sum subject to the conditions enumerated in the above said order.
