ORDER

Bail application filed by accused No.1 to 4 U/Sec.437 of Cr.P.C is hereby allowed subject to following:

CONDITIONS

1. Accused No 1 to 4 shall appear before Court on all date of hearing without fail.
2. Accused No 1 to 4 shall not involve in similar type of offences.
3. Accused No 1 to 4 shall not hamper or tamper prosecution witnesses.
4. Accused No 1 to 4 shall execute personal bond for Rs 50,000/- with two sureties for likesum.
