The above named petitioner has filed this petition U/Sec.166 of M.V.Act claiming compensation of Rs.6,50,000/- with interest at the rate of 12% p.a. for the accidental injuries sustained by him in the motor vehicle accident,that occurred on 15-09-2023 at about 3-30 pm at N.H. 66, near Shiroor Kelapete Darga, Byndooru.due to rash and negligent driving of Bike bearing No.KA-20-EU6684.

The Petition presented before the Prl. MACT. Karwar, and subsequently transferred to this Tribunal.

While this petition is pending before this Court joint memo was filed by the petitioners and respondent No.2 and the petition came for final disposal at Lok Adalath before Smt. B.S.Rayannawar, B.A.L.L.B. Member, Addl. M.A.C.T. Kumta and Judicial Conciliator and Sri.B.D.S., Advocate for Non-

Judicial Conciliator in the presence of Sri.V.R.B.,Advocate for Petitioner, Sri.S.M.B.,Advocate for Respondent No.2, and the Respondent No. 1, placed exparte.

It is ordered and awarded that :

Petitioner and the respondent No.2 have filed this joint memo stating that the matter has been settled between them for a sum of Rs.3,60,000/- (Rupees Three Lakhs Sixty thousand only).

In view of the aforesaid joint memo filed by the petitioner and the respondent No.2, petition of the petitioner is allowed. Respondent No.2 is directed to deposit the aforesaid settled amount of Rs.3,60,000/- within one month from the date of award. Failing which the respondent No.2 is liable to pay interest at the rate of 6% p.a. from today till realization.

Joint memo filed by the petitioner and the respondent No.2 also forms the part and parcel of the said award.
