**ORDER ON COMMITTAL U/SEC.232 of B.N.S.S.**

C.P.I. of Haliyal Cirle has chargesheeted accused No.1 to 3 for the offences punishable Under Sections 108 and 318(2) R/w Section 3(5) of BNS 2023.

2. Since the offence alleged under Section 108 of BNS 2023 is exclusively triable by the Hon'ble District and Sessions Court, this case is required to be committed to the Hon'ble I Addl. District and Sessions Court, Karwar, sitting at Sirsi.
