CHARGE

I, **Kiran S. Gangannavar**, Principal

hereby charge you,

Mohammed Althaf,
S/o M. Abubakkar Saheb,
Aged about 57 years,
R/at H.No. 5-181-A-181
Penta Hights Indrali, 1st Cross,
Indrali, Manipal, Udupi.

as follows:-

That, on 21.12.2023 at about 7.30p.m., near Penta Hights Building, at 5B Cross, V.P. Nagar, Indrali of Shivalli Village, while CW1 was offering food to the dogs, you accused asked her to do so on the hind side of the building and to place the food on the floor itself and attempted to snatch the food bowl, when CW1 objected for the same, with an intention to outrage her modesty, pulled her saree and thereby committed an offence punishable U/Sec.354B of IPC and within the cognizance of this Court.

That, on the above said date, place and time you accused, knowing fully well that CW.1 belongs to Scheduled Caste, intentionally insulted her in public view and public place by abusing her in filthy language by taking the name of her caste that "ದಿಕ್ಕನಿಗೆ ಹುಟ್ಟಿದವಳೇ, ನಾಯಿ ಜಾತಿ ನೀನು" and thereby committed an offence punishable U/Sec.504 of IPC and U/Sec.3(1)(s) of Scheduled Caste & Scheduled Tribe (Prevention of Atrocity) Act, 1989 and within the cognizance of this Court.

That, on the above said date, place and time, you Accused threatened CW.1 with life saying that ನೀನು ಇನ್ನು ಮುಂದೆ ಈ ರಸ್ತೆಯಲ್ಲಿ ಬಂದು ನಾಯಿಗಳಿಗೆ ಊಟ ಹಾಕಿದರೆ ನಿನ್ನನ್ನು ಮತ್ತು ಇಲ್ಲಿಯ ನಾಯಿಗಳನ್ನು ಕೊಂದು ಬಿಸಾಡುತ್ತೇನೆ" with an intention to cause alarm to her and thereby committed an offence of criminal intimidation punishable U/Sec.506 of IPC and within the cognizance of this Court.

That, on the above said date, place and time you Accused intentionally insulted or intimidated CW.1 a member of Scheduled Caste and committed atrocity on her and thereby, committed an offence punishable U/Sec. 3(1)(r) and U/Sec.3(2)(v-a) of Scheduled Caste and Scheduled Tribe (POA) Act, 1989 and within the cognizance of this Court.

And I hereby direct that you be tried before me of the said charges.
