charge you:

as follows:-

FIRSTLY: That you accused-1 to 5, on 01.02.2023 at about 7:00 PM., at Narthaki Bar & Restaurant, Chitrapadi, Saligrama Village, Brahmavara Taluk, formed an unlawful assembly in prosecution of common object of committing dacoity in the bar & restaurant of Cw1; thereby committed an offence punishable

under Section 143 r/w Section 149 of the Indian Penal Code, and within my cognizance.

SECONDLY:- That on the above said date, time and place, you the accused No.1 to 5 were the members of an unlawful assembly with the above said common object you have committed rioting and thereby committed an offence punishable under Section 147 r/w Section 149 of the Indian Penal Code, and within my cognizance.

THIRDLY:- That on the above said date, time and place, you the accused No.1 to 5 were the members of an unlawful assembly with the above said common object committed rioting, armed with deadly weapons and thereby committed an offence punishable under Section 148 r/w Section 149 of the Indian Penal Code, and within my cognizance.

FOURTHLY: That on the above said date, time and place, you the accused No.1 to 5 were the members of an unlawful assembly with the above said common object, assaulted Cw1 & 4 with hands, legs & pushed them and caused

simple injuries and thereby committed an offence punishable under Section 323 r/w 149 of the Indian Penal Code, and within my cognizance.

FIFTHLY: That on the above said date, time and place, you the accused No.1 to 5 were the members of an unlawful assembly with the above said common object, you (A1) assaulted Cw4 with beer bottle on head causing injury and thereby committed an offence punishable under Section 324 r/w 149 of the Indian Penal Code, and within my cognizance.

SIXTHLY: That on the above said date, time and place, you the accused No.1 to 5 were the members of an unlawful assembly with the above said common object, you assaulted Cw4 by hands and beer bottle with an intention to kill him and thereby committed an offence punishable under Section 307 r/w 149 of the Indian Penal Code, and within my cognizance.

SEVENTHLY: That on the above said date, time and place, you the accused No.1 to 5 were the members of an unlawful assembly with the

above said common object, you destroyed table, chair and aluminum door causing loss of Rs.5,000/- and thereby committed an offence punishable under Section 427 r/w 149 of the Indian Penal Code, and within my cognizance.

EIGHTHLY: That on the above said date, time and place, you the accused No.1 to 5 were the members of an unlawful assembly with the above said common object, abused Cw1 & 4 in filthy language, with an intention to provoke breach of the peace and thereby committed an offence punishable under Section 504 r/w 149 of the Indian Penal Code, and within my cognizance.

LASTLY: That on the above said date, time and place, you the accused No.1 to 5 were the members of an unlawful assembly with the above said common object, threatened Cw1 & 4 with dire consequences and thereby committed an offence punishable under Section 506 r/w 149 of the Indian Penal Code, and within my cognizance.

And I hereby direct that you be tried before me on the said charges.
