FIRSTLY: That, on 17.06.2019 at about 2:00 a.m. you Accused No.3 and 4 along with Accused No.1 in Split Up S.C.No.16/2023 and deceased Accused No.2 in furtherance of your common intention committed theft of Mahindra Bolero Pickup vehicle bearing Reg.No.KA-19-C-8184 belonging to CW.1 Mohammad Rakeeb worth ₹1,50,000/- parked in front of Shrinidhi Complex at Kallapu, Moodabettu Vilage, Kapu by using a duplicate key in order to sell the same for your personal gain and thereby committed the offence punishable U/Sec.379 r/w Sec.34 of Indian Penal Code, within the cognizance of this Court.

SECONDLY: That, you Accused No.3 in order to conceal vehicle stolen by Accused No.1 in Split Up S.C.No.16/2023 and deceased Accused No.2, in furtherance of your common intention took it to Mettupalyam Taluk, Coimbatore District, Tamil Nadu and sold the same to Accused No.4 and thereby committed the offence punishable U/Sec.414 r/w 34 of Indian Penal Code, within the cognizance of this Court.

THIRDLY: That, you Accused No.4 being habitual dealer of stolen property had received Mahindra Bolero Pickup vehicle of CW.1 Mohammad

Rakeeb knowing fully well that the said vehicle is stolen by the Accused No.1 and 2 and thereby committed the offence punish U/Sec.413 r/w 34 of Indian Penal Code, within the cognizance of this Court.

LASTLY: That, you Accused No.3 to 4 along with Accused No.1 in Split Up S.C.No.16/2023 and deceased Accused No.2 in furtherance of your common intention in order to destroy the evidence had removed the number plate and erased the engine and chasis number of the stolen Mahindra Bolero Pickup bearing Reg.No.KA-19-C-8184 and thereby committed the offence punishable U/Sec.201 r/w 34 of Indian Penal Code within the cognizance of this Court.

And I hereby direct that you be tried before me on the said charges.
