CHARGE

I, **Shantaveer Shivappa, B.A., LL.B.**
(Spl.), Principal Sessions Judge/P.O., Special
Court, Udupi hereby charge you,

Manoj Shetty @ Manoj Kumar,
S/o. Late Keshava Shetty,
Aged about years,
R/at.H.No.2-10,
Uchilla Bada Village,
Kapu Taluk, Udupi District.

as follows:-

FIRSTLY: That, on 25.02.2022 at about 8:45 a.m. as per the instructions of Grama Panchayath, CW.1 Smt. Susheela along with CW.2 to 5 and 9 was dumping the garbage in a place identified by the Panchayath near Babbuswamy Temple Road, Polya, Bada Village

at that time you Accused abused her in filthy language knowing fully well that she belongs to schedule caste by taking the name of her caste that “ಸೂಳೆ ರಂಡೆ, ಕೀಳು ಜಾತಿಯ ನಿಮಗೆ ಮಾಡಲು ಬೇರೆ ಕೆಲಸ ಸಿಗುವುದಿಲ್ಲ.” in public place and public view intending to provoke CW.1 to commit any other offences and thereby committed an offences punishable U/Sec.504 of Indian Penal Code and U/Sec.3(1)(s) of Scheduled Caste/Scheduled Tribe (Prevention of Atrocity) Act, 1989 within the cognizance of this Court.

SECONDLY: That, you Accused on the above said date, time and place slapped on the left cheek of CW.1 Smt. Susheela by hands voluntarily causing simple hurt to her and thereby committed the offence punishable U/Sec.323 of Indian Penal Code within the cognizance of this Court.

THIRDLY: That, you Accused on the above said date, time and place in order to intentionally cause wrongful loss and damage smashed the Oppo Company mobile phone of CW.1 Smt. Susheela valued at ₹5,000/- on the concrete road and thereby committed the offence punishable U/Sec.427 of Indian Penal Code within the cognizance of this Court.

FOURTHLY: That, you Accused on the above said date, time and place committed criminal intimidation by threatening CW.1 Smt. Susheela with an intention to cause alarm to her stating that “ಇನ್ನೊಮ್ಮೆ ಈ ಜಾಗಕ್ಕೆ ಬಂದರೆ ಕೈಕಾಲು ಕಡಿದು ಹಾಕುತ್ತೇನೆ” and thereby committed an offence punishable U/Sec.506 of Indian Penal Code within the cognizance of this Court.

LASTLY: That, you Accused on the above stated date, time and place insulted or intimidated CW.1 Smt.Susheela a member of Scheduled Caste and thereby, committed an offence punishable U/Sec. 3(1) (r) and U/Sec.3(2)(v-a) of Scheduled Caste and Scheduled Tribe (POA) Act, 1989 within the cognizance of this Court.

And I hereby direct that you be tried before me of the said charges.
