CHARGE

Court, Udupi hereby charge you,

as follows:-

FIRSTLY: That you Accused No.1 being a public servant working as an In-charge Regional Transport Officer in the Regional Transport Office, at Udupi District, **on 15-3-2019**, demanded illegal gratification of ₹6,500/- from C.W.1 complaint for refund of remaining road tax amount of ₹65,000/-, issuing DL and cancellation of RC with respect to Volkswagen Vento Car No.KA-20-P-5464 which was burnt on 23.02.2019 in a fire accident taken place at Yelahanka Air Show, Bengaluru, when C.W.1 informed his inability to pay ₹6,500/-, you accused No.1 asked to pay ₹5,000/- and **on 16-3-2019 at Office of the RTO, Udupi District**, received **Rs.4,000/-** from the C.W.1, same was handed over to Accused No.2 to keep it with him, prior to receiving bribe from the C.W.1, received a sum of ₹30,670/- from others, as gratification other than legal remuneration as bribe and thereby you Accused No.1 committed an offence punishable U/Sec.7(a) of the Prevention of Corruption Act, 1988 and within the cognizance of this Court.

SECONDLY: That, you Accused No.2 being Security Guard deputed on contract basis through C.W.7 Private Company on the above said date and place assisted the Accused No.1 in taking bribe by keeping ₹4,000/- received from C.W.1 and ₹30,670/- possessed without

any documents in the 3rd wooden cupboard kept in the middle of transport section room, in front of the room of RTO and thereby committed the offence punishable U/Sec.7(A) of Prevention of Corruption Act, 1988 and within the cognizance of this Court.

LASTLY:- That, on above said date and place you Accused No.1 abetted the Accused No.2 to commit the above said offence and thereby committed an offence punishable U/Sec.12 of the Prevention of Corruption Act, 1988, and within the cognizance of this Court.

And I hereby direct that you be tried before me on the said charges.
