



and it bears my signature and same is marked as **Ex.P-11** and signature of the witness is marked as **Ex.P- 11(a)**.

5) On the same day at 11.35 p.m., I examined One Narayana, aged about 27 years, brought by Udupi town Police, with a history of self inflicted injury.

6) On examination of the patient, I found following injuries.

Laceration at the base of left thumb dorsal aspect measuring 1.5 cm x 0.5 cm.

7) I am of the opinion that, the injury is simple nature. Accordingly, I issued wound certificate. Now I see said Wound certificate and it bears my signature and same is marked as **Ex.P-12** and signature of the witness is marked as **Ex.P-12 (a)**.

8) On 21-03-2025 at 6.33 p.m., I examined C.W.2 , aged about 33 years, with a history of stab injury by unknown person on 20-03-2025 at about 11.00 p.m.

9) On examination of the patient, I found following injuries.

1. Incised looking wound about 3 c.m. anterior to left pinna of ear 1 cm x 0.5 cm.

2) Incised looking wound about measuring 1 c.m x 0.5 cm left side chest near lower rib border.

3) Incised looking posterior aspect of upper arm measuring 1x 0.5 c.m.

4) Incised looking wound left flank 1 cm x 0.5 cm.

5) Incised looking wound posterior aspect base of the neck 1 cm x 0.5 cm.

6) Incised looking wound just lateral to L1, L2 vertebra 1x 0.5 c.m.

10) I am of the opinion that, the injury No.1to 6 are simple in nature. However, as the patient left against medical advise. Final opinion may be given after viewing complete treatment records. Accordingly, I issued wound certificate. Now I see said Wound certificate and it bears my signature and same is marked as **Ex.P-13** and signature of the witness is marked as **Ex.P-13 (a)**.

11) On 26-05-2025, I.O sent a requisition to examine a Knife sent with the requisition to record the opinion about the possibility of the injury of Ex.P.11 and 13 for having caused by the weapon under examination. I examined the Knife sent by the Investigating Officer. After examination, I am of the opinion that, injuries mentioned in the wound certificates of C.W.1 and C.W.2, can be caused by this weapon. Now I see said reports and same is marked at **Ex.P. 14 and 15** and signature of the witness is marked at Ex.P.13(a) and Ex.P.14(a).

12) After examination, I returned the knife to the Investigating Officer in a sealed condition with sample of my seal and opinion regarding weapon. I can identify the Knife examined by me on that day. Now I see the same knife and same is already marked at M.O.1.

13) The injury mentioned at Ex.P.12 may be caused while assaulting with person with M.O.1.

**Cross examination by: Sri. R.P. (LADC) Advocate for Accused.**

1) CW.1 and 2 they were oriented when at the time of examination. I didn't mentioned the persons accompanying the injured for examination. In both Ex.P.11 and 13 does not disclose either the time of assault and the person assaulting. The injuries mentioned at Ex.P.11, will not be caused by the contact of barbed wires. It is false to say that, CW.2 did not suffer the injuries mentioned in Ex.P.13. Said injured came in the next day morning, but not in the evening. It is false to say that, CW.2 came at 6.33 p.m., it is a.m. It is false to say that, injuries of Ex.P.13 may be caused by falling on the sharp object, because they are occurred in different places. Therefore, single fall cannot be caused all these injuries.

2) It is false to say that, injuries mentioned in Ex.P.11, 12, 13, cannot be caused by M.O.1. Self infliction of injury may be caused by the instabilized mind. I did not opine M.O.1 in-respect of Ex.P.12. It is false to say that, injuries of Ex.P.12 cannot be caused by M.O.1. It is false to say that, I issued Ex.P.11 and 13 at

the instance of the I.O. to help his investigation. It is false to say that, Ex.P.14 and 15 are concocted to support Ex.P.11 and 13. It is false to say that, now I am deposing to help the police in the investigation.
