Udupi hereby charge you,

1. Preetham, S/o Somayya,
Aged about 24 years,
R/at Darkas House,
Palimaru Post and Village,
Kaup Taluk, Udupi District.
2. Ashoka, S/o Prem Dami,
Aged about 27 years,
R/at House No. 2-105-34,
Rajeeva Nagara, Palimaru Post,
Nandikuru Village,
Kaup Taluk, Udupi District.
3. Sukesha, S/o Mohan Poojary,
Aged about 33 years,
R/at House No. 2-105-6,
Rajeeva Nagara, Palimaru Post,
Nandikuru Village, Padubidri,
Kaup Taluk, Udupi District.

as follows:-

That, on 08.06.2023 at about 20.50 hours, at Asthapadpu Ground, Nandikoor Village, Kaup Taluk, you accused No.1 along with accused Nos.2 and 3 being the friends of the CW1, with common intention to commit certain offences against CW1, while he was proceeding on the motor cycle as pillion rider along with CW's 4 and 5, wrongfully restrained the motor cycle, which was ridden by CW4 and thereby committed an offence punishable U/Sec.341 r/w Section 34 of IPC and within the cognizance of this Court.

That on the above said date, time and place, you accused No.1 along with accused Nos.2 and 3 in furtherance of aforesaid common intention, voluntarily caused hurt to CW4 by assaulting with beer bottle and thereby committed an offence punishable U/Sec.324 r/w Section 34 of IPC and within the cognizance of this Court.

That on the above said date, time and place, you accused No.1 along with accused Nos.2 and 3 in furtherance of aforesaid common intention, voluntarily caused hurt to CW's 1, 4 and 5 by assaulting them with bare hands and thereby committed an offence punishable U/Sec.323 r/w

Section 34 of IPC and within the cognizance of this Court.

That on the above said date, place and time, you accused No.1 along with accused Nos.2 and 3 in furtherance of common intention, criminally intimidated CW's 1, 4 and 5 by threatening to kill them with an intention to cause alarm to them and thereby committed an offence of punishable U/Sec.506 r/w Sec.34 of IPC and within the cognizance of this Court.

That on the above said date, time and place, you accused Nos.2 and 3 in furtherance of common intention, knowing very well that CW.1 is a member of Scheduled Caste "Mundala Community, committed atrocity on him by wrongfully restraining, voluntarily causing hurt by means of club, stamping CW's 1 and 5 with leg, and thereby committed an offence punishable U/Secs. 341, 323, 324 r/w Sec.34 of IPC and Sections 3(2)(v-a) of Scheduled Caste and Scheduled Tribe (POA) Act, 1989 and within the cognizance of this Court.

That on the above said date, time and place, you accused Nos.2 and 3, in furtherance of

common intention, knowing very well that CW.1 is a member of Scheduled Caste "Mundala Community, committed atrocity on him by criminally intimidating as ಇನ್ನು ನಮ್ಮ ವಿಷಯಕ್ಕೆ ಬಂದರೆ ಕೊಲ್ಲದೇ ಬಿಡುವುದಿಲ್ಲ and thereby committed an offence punishable U/Sec 506 r/w Sec.34 of IPC and Sections 3(1)(r) of Scheduled Caste and Scheduled Tribe (POA) Act, 1989 and within the cognizance of this Court.

That on the above said date, time and place, you accused Nos.2 and 3, in furtherance of common intention knowing very well that CW.1 is a member of Scheduled Caste "Mundala Community, committed atrocity abusing him by caste name in a place within public view as "ದಿಕ್ಕುಗ್ ಪುಟ್ಟಿದಿನಾಯ, ಮೋಟಾರ್ ಸೈಕಲ್ ತಿರ್ತ್ ಜೆಪ್ಪು, ಬೇವರ್ಸಿ and thereby committed an offence punishable U/Sec 504 r/w Sec.34 of IPC and Sections 3(1)(s) of Scheduled Caste and Scheduled Tribe (POA) Act, 1989 and within the cognizance of this Court.

And I hereby direct that you be tried before me of the said charges.
