I do swear the contents of my affidavit are true and correct. I can identify the signature and Thumb impression as deposed by me. I now see Registered will Ex. D.13 the thumb impression is put by Baiku Poojary and I have identified the thumb impression of the Testator of will on all pages. The thumb impression is put in my presence marked as Ex.D 13 (c to g). Two witnesses have signed the will in my presence Annappa Shetty and Sanjeeva Maben. (Counsel for plaintiff objects as subject to proof). The Testator had put thumb impression in my presence and in presence of witnesses. I can identify signature of Annappa Shetty which is marked as Ex.D.13(h). Similarly Sanjeeva Maben has signed as per Ex.D. 13(a) (Plaintiff counsel objects for the

identification of signature as subject to proof). The signature made by Annappa Shetty is seen by Testator Baiku Poojary and Sanjeeva Maben. The Baiku Poojary and Annappa Shetty had observed when Sanjeeva Maben signed as a witness. (Plaintiff counsel objects for the identification of signature as subject to proof). I had signed the document as scribe Ex.D.13(i). The signing of the document is done in my presence in my office, i.e Ex.D.13 (a to h). On the same day Baiku poojary presented Ex.D.13 for registration before Sub-Registrar, Udupi. The Ex.D.13 is signed by the testator and also Annappa Shetty and Sanjeeva Maben as witnesses. (Plaintiff counsel objects for the identification of signature of Sanjeeva Maben Ex.D 13(b) as subject to proof). The thumb impression Ex.D.13 (j and k) are made by Baiku Poojary in presence of sub registrar. The signature of Annappa Shetty before sub registrar office is marked as Ex.D. 13(L). The sub registrar was Chandrashekar Aithal K. The sub registrar is not living, I can identify the signature as per Ex.D.13 (m to p). My father was also working as document writer. I can identify the signature marked as Ex.D. 12(a). Ex. D.12 is written by my father in his own hand writing. The Ex.D.12 is executed by Baiku Poojary, as identified me in Ex.D. 13.

The Baiku Poojary is one claims of my father since long. My father had worked as document writer to since 1952 till his death in the year 1983.
