Petition filed under Sec. 166 of M. V. Act, 1988, by the petitioner to claim a sum of Rs.15,00,000/- being the compensation by the petitioner for the Injuries caused in a motor vehicle accident alleged to have been caused due to the rash and negligent driving of the motor cycle bearing Regd. No. KA-20-L-1359 on 08-09-2022 at about 12.30 p.m., Near Ajjarkadu Hospital, Udupi.

This petition coming on 07-07-2026 for final disposal before me in the presence of Sri. P.S., Advocate for petitioner and Sri.B.K., Advocate for R1 and R2 and R3 is deleted and and of Sri. M.R., Advocate for R4 and the matter stood over

for consideration till this day, this court doth hereby order and award as follows:

1. That, the claim petition filed under Section 166 of Motor Vehicle Act, by petitioner against respondents is hereby allowed in part with cost.
2. That, the petitioner is entitled for total compensation of **Rs.5,71,984/-**-(Rupees Five Lakhs Seventy One Thousand Nine Hundred and Eighty Four Only) with interest at the rate of 6% p.a.,from the date of petition till date of realization.
3. That, the respondents no.1, 2 and 4 are jointly and severally liable to pay compensation and respondent no.4 is directed to deposit the compensation within 30 days from the date of this order .
4. That, upon deposit of the compensation amount the petitioner is entitled to receive 75% of the compensation amount and the remaining 25% of compensation is ordered to be deposited in any Nationalized bank for a period of 3 years.
5. That, office is hereby directed to transfer entire amount to the petitioner after obtaining copy of the pass book, copy of Aadhar card and PAN card if any.

6. That, the respondents shall pay to the petitioner the sum of Rs.1,135=00 towards the cost of the petition.
