CHARGE

Firstly, on 04.09.2021 at and around 09.10 p.m. within
the jurisdiction of Padubidri Police Station, near
Raghavendra Mutt, Kanchinadka, Nadsalu Village, Kaup
Taluk you accused No.1 to 3 used unparliamentary words to
cause insult and annoyance to C.W.2 to 7 and thereby

committed the offence punishable under Section 504 r/w 34 of I.P.C and within my cognizance.

Secondly, that on the above said date, place and time, you the accused No.1 to 3 assaulted the C.W.2 to 7 and caused simple injuries and thereby committed the offence punishable under Section 323 r/w 34 of I.P.C. and within my cognizance.

Fifthly, that on the above said date, place and time, you the accused No.2 and 3 have committed criminal intimidation by giving life threat to C.W.2 and thereby committed an offence punishable under Section 506 r/w 34 of I.P.C. and within my cognizance.

Sixthly, that on the above said date, place and time, you the accused No.2 and 3 have illegally trespassed into the house of C.W.8 and 10 and thereby committed the offence punishable under Section 448 r/w 34 of I.P.C. and within my cognizance.

Lastly, that on the above said date, place and time, you the accused No.2 and 3 have committed damage to the cement sheet of the house and caused monetary loss of Rs.200/- to C.W.10 and thereby committed an offence punishable under Section 427 r/w 34 of I.P.C. and within my cognizance.

And I do hereby direct you to be tried for the above said charge and within the cognizance of this court.
