PLEA

I, **Santosh Srivastava** B.A., LL.B., Addl. Sr. Civil Judge & A.C.J.M., Udupi, do hereby charge you as under:-

Firstly, you accused No.3 along with accused No.1 and 2 with a common intention, on 23.04.2019 within the jurisdiction of Padubidri Police Station, at Adyaru Post, Mangaluru Taluk have stolen of 15 Metric-ton of sand worth of Rs.14,820/- from the river situated at Arukula bearing Sy.No.44 which belongs to the Government, without consent and to cause loss, thereby committed an offence punishable under Section 379 of I.P.C. within cognizance of this Court.

Secondly, that on the above said date, place and time, you being the accused No.3 along with accused No.1 and 2

without valid permit used the tipper lorry bearing Reg.No.KA-46-3202 for loading sand, thereby committed the offence punishable under Section 66 r/w 192(A) of IMV Act, within cognizance of this Court.

Thirdly, on 24.04.2019 at about 5.00 a.m. within the jurisdiction of Padubidri Police Station, on N.H.66, Nadsalu Village, Kaup Taluk, when C.W.1 to 3 restrained the tipper lorry bearing Reg.No.KA-46-3202 with loaded sand driven by you by using departmental barricade, at that time you accused No.3 without stopping the vehicle drove the said vehicle by causing damage to the barricade, thereby caused damage worth of Rs.1,000/- to the public property , which is an offense punishable under Section 3 of Karnataka Prevention of Damage to Public Property Act, 1984, within cognizance of this Court.

And I do hereby direct you to be tried for the above said charge and within the cognizance of this court.
