Petition was presented on 14-11-2024 and registered on 21-11-2024.

Petition filed under Sec.166 of the M. V. Act. 1988,as amended by the petitioner to claim a sum of ₹.40,00,000/-being the compensation by the petitioner for the Injuries caused in a motor vehicle accident alleged to have been caused due to the rash and negligent driving of the car bearing Regd. No. KL-60-E-7131 on 21-04-2024 at about 8.30 a.m., Near Janal Cross, Hosur Village, Kundapura Taluk.

This petition coming on 15-07-2026 for final disposal before me in the presence of Sri. S.A.,Advocate for petitioner and of Sri.U.K., Advocate for R1 & R2 and Sri. A.S.B.,Advocate for R3 and the matter stood over for consideration till this day, this court doth hereby order and award as follows:

1. That, the petition filed by the petitioner under Sec. 166 of Indian Motor Vehicles Act,1988 is allowed in part with costs.
2. That, the petitioner is entitled for

compensation of **Rs.2,89,500/-** (Rupees Two Lakhs Eighty Nine Thousand Five Hundred Only) along with interest at the rate of 6% per annum from the date of petition till realization.

3. That, the respondent No.1 to 3 are jointly and severally liable to pay the award amount. Since the respondent No.3 is the insurer, the respondent No.3 is directed to pay the compensation and the same shall be deposited within 45 days from the date of this order.
4. That, after deposit the award amount with proportionate interest is ordered to be credited to the bank account of the petitioner either through N.E.F.T. or R.T.G.S.
5. That, respondents shall pay to the petitioner the sum of Rs.1,139=00 towards the cost of the petition.
