COMMITTAL ORDER

The Sub-Inspector of Police, Karkala Town Police Station has filed the charge sheet against the accused No.1 to 3 for the offence punishable under Sections 379 r/w 34 of IPC and Sec. 5, 12 of Karnataka Prevention of Slaughter and Prevention of Cattle Ordinance 2020.

2. In crime stage accused No.1 to 3 are produced before this court on 21.02.2022 and released on bail.

3. After filing of charge sheet, cognizance of the offence taken and case registered in C.C. register.

4. Today accused No.1 to 3 are present and Charge sheet copy furnished to the accused No.1 to 3 under Sec. 207 of Cr.P.C.

5. Heard learned A.P.P

6. Perused the prosecution papers.

7. In this case, the Investigation Officer has filed the charge sheet against the accused No.1 to 3 for the offence punishable Sections 379 r/w 34 of IPC and Sec. 5, 12 of Karnataka Prevention of Slaughter and Prevention of Cattle Ordinance 2020. The Sec.5, 12 of Karnataka Prevention of Slaughter and Prevention of Cattle

Ordinance 2020 exclusively triable by Hon'ble Court of Sessions. Hence this court cannot proceed with the case and it is a fit case for committal. Hence, I proceed to pass the following:

ORDER

Acting under Section 209 of Cr.P.C.
the case against the accused No.1 to 3 are
committed to the Hon'ble Principal District
and Sessions Judge, Udupi.

The Office is directed to submit entire
records to the Hon'ble Principal District and
Sessions Court, Udupi and notify the
committal of the case to the public
prosecutor and the accused No.1 to 3.

Accused No. 1 to 3 are directed to
appear before the Hon'ble Prl. District and
Sessions Court, Udupi, when summoned.

The IO is directed to produce material
objects in the Court of Session.
