The plaintiff above named begs to state as follows:-

- 1) That the plaintiff is the owner and possessor of the property described in the schedule below. The plaintiff got the schedule property from his mother Maya Debnath W/o. Late Ganga Pada Debnath by way of Deed of Gift being No. 941/2018.
- 2) That after getting the schedule property from his mother the plaintiff mutated his name in the office of the B.L&L.R.O and has been paying rent and Panchayet tax to the concerned authority and has been possessing the same peacefully, uninterruptedly and without any interruption from anybody else.
- 3) That the defendant no.1 is the elder brother of the plaintiff who is very greedy and a man of influential and so many political leaders and muscle man in his hand and out of previous grudge and enmity suddenly on 11/08/2026 at about 9 a.m. the defendants with some masons and labourers entered into the schedule property and started to construct boundary wall in the schedule property of the plaintiff.
- 4) That after seeing the said act of the defendants the plaintiff requested the defendant no.1 not to do the illegal act but the defendants turned a deaf ear more so they threatened the plaintiff with dire consequences.
- 5) That being afraid, the plaintiff informed the above facts before the Nabadwip Police Station on 11/08/2026 but the Police authority did not care about the facts of the plaintiff but also lodged a G.D.E No. 904 dt. 11/08/2026.

Thereafter the plaintiff informed the illegal act of the defendants to the I.C Nabadwip Police Station and S.P Nadia at Krishnagar on 12/08/2026 by Speed Post.

- 6) That the defendants are constructing boundary wall in the schedule property illegally, whimsically and by force. The defendants have no right, title, interest and possession over the schedule property.
- 7) That the cause of action of this suit arose on 11/08/2026 and thereafter continuing day to day at village Charmajdia P.S. Nabadwip, Dist. Nadia within the jurisdiction of this Ld. Court.
- 8) That the plaintiff values the suit at Rs. 100/- and paid ad-valorem Court fees on the same and files this suit and prays :-
 - a) That a decree for declaration be passed that the plaintiff is the owner and possessor of the schedule property;
 - b) That a decree be passed against the defendants that the defendants have no right to construct boundary wall over the schedule property;
 - c) That a decree be passed against the defendants in favor of the plaintiff so that the defendants cannot construct boundary wall over the schedule property without due process of law;
 - d) That a decree also be passed so that the defendants may not dispossess the plaintiff and/or not to enter into the schedule property and/or not to create any disturbances in the peaceful possession of the schedule property;
 - e) Any other relief or reliefs which the plaintiff is entitled to get in the eye of law and equity;
 - f) Costs of the suit.
