APP. ---- A petition for bail vide this Misc. Criminal Application filed on behalf of accused/petitioner namely Manoj Burh (who is in judicial custody since 04.10.2022) aged about 27 years S/o Kanu Burh, R/o village-Jiliguttu, P.O.- Robkera, P.S.- Goilkera, Dist.- West Singhbhum, in connection with A.H.T.U. PS Case No.13/2022 for the offence u/s 363 & 370 of IPC and 75/81 of J.J. Act is put up for hearing. Copy of the same has also been served to Ld. APP. It is submitted by learned counsel appearing on behalf of the accused/petitioner that previously he has not preferred any bail application before any Court. Ld. counsel further submitted that he is innocent, has committed no offence as alleged in the FIR and has been falsely implicated in this case. Nothing has been happened as alleged in the FIR, in fact the victim is relative of the petitioner and petitioner take the victim with him to take her proper care and well education. Nothing has been recovered from the conscious possession of the petitioner. Petitioner is in custody since 04.10.2022 and ready to furnish sufficient sureties to the satisfaction of the Court. On behalf of State, Ld. A.P.P. opposed the prayer for bail of this accused/petitioner submitting that offence is serious as well as non-bailable in nature and exclusively triable by the Court of Sessions. Since the FIR was lodged on 03.10.2022 by informant Sunita Panna, Invigilator, Railway Protection Force, Women Protection Cell, Ranchi against this very accused/petitioner registered u/s 363 & 370 of IPC and 75/81 of J.J. Act mentioning therein that on 03.10.2022 while informant along with others was on checking duty at Ranchi Railway Station regarding illegal human trafficking of child, at about 04:00 P.M. she saw one person along with one minor girl, who was scared, at Platform

On suspicion, they were inquired and they disclosed their names as Saniyara Horo aged about 12 years but she could not tell any satisfactory answer about the said person and she only stated that she was going Delhi with the said person. On query with the said person, he disclosed his name as Manoj Burh (present petitioner) and the minor girl was the daughter of sister-in-law (Sali) of neighbour maternal uncle of the village of his maternal uncle and he had come on the same day from Delhi by Garib Rath Express Train bearing No.12878 to take the said girl to Delhi for getting her job in any home. Hence, the present case has been lodged. Though, this accused/petitioner has been remanded in this case on <u>04.10.2022</u> and <u>since then he is behind the bar</u> but the offences as alleged against him is serious as well as non-bailable in nature and exclusively triable by the Court of Sessions. Considering the aforesaid facts and gravity of the offence, I am not inclined to enlarge the accused/petitioner on bail. Hence, prayer for bail of the accused/petitioner namely Manoj Burh is hereby rejected. Accordingly, this Misc. Criminal Application No.<u>6883/2022</u> is hereby disposed of. (Dictated) Sd/- (M.K.
