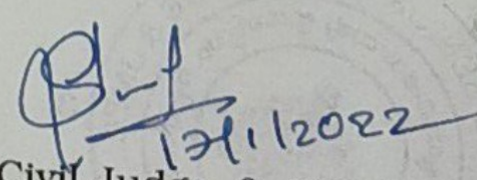
It is ordered and decreed that:-

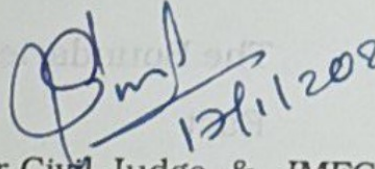

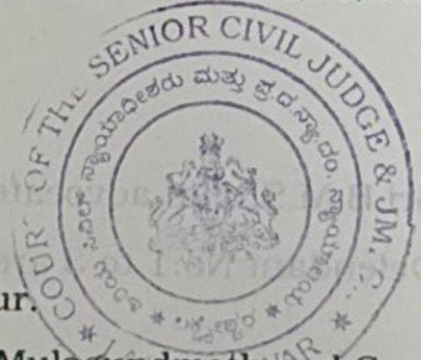

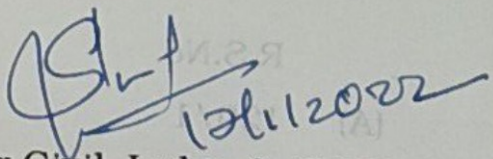
