C.W.1 is my mother. Deceased Sri. Galya Naik is my elder brother. To my parents we are 6 sons and 3 daughters. Accused No.1 is wife of deceased Sri. Galya Naik. Accused No.2 is the father of accused no.1. The marriage of deceased Sri. Galya Naik with the accused no.1 took place more than 15 years ago. In their wedlock 4 children were born out of whom two children are dead and two children (a boy and a girl) are alive. 13 days after their marriage they left my parents house. They were living separately in our village itself for few days. They went to Goa in search of job. They lived there for some time. During their stay at Goa, deceased Sri. Galya Naik had got fractured his leg. My father and accused no.2 had gone to Goa and brought them back. Thereafter, they went to Harihara for doing coolie work to the sugarcane crops. At Harihara the deceased Sri. Galya Naik and the accused no.1 had quarrel with each other. They lived at Chitradurga for sometime. The accused no.2 had brought them and kept them in Shivapura village, Kudligi taluk. The deceased Sri. Galya Naik was running a small hotel at Shivapura village.

On 22.01.2019, the accused no.1 telephoned to accused no.2 regarding the problem between the deceased Sri. Galya Naik and the accused no.1. On 22.01.2019 the accused no.2 and four others had come to the house of deceased Sri. Galya Naik at Shivapura and beaten him. Thereafter, the deceased Sri. Galya Naik had telephoned to my parents house and informed about the said incident. On the same day, the deceased Sri. Galya Naik had consumed poison. Deceased Sri. Galya Naik telephoned to one Sri. Kotresh (C.W.7) and informed that due to the said incident he was about to consume poison. Said Sri. Kotresh took the deceased Sri. Galya Naik to Government Hospital, Kudligi. From there the accused no.1 and 2 and others have taken deceased Sri. Galya Naik to VIMS Hospital, Ballari. At that relevant point of time I was at Goa. On 24.01.2019 I came to Ballari from Goa. My mother as well as said Sri. Kotresh informed me about the above noted facts. After I returned to Ballari, on the same day or the next day, the deceased Sri. Galya Naik died at the said Hospital.

Kudligi Police had come to VIMS Hospital, Ballari. My mother (C.W.1) gave complaint to the Police. We returned back to Bandebasapura thanda, after cremation of the dead body. Thereafter, the P.S.I., Kudligi, called my brother C.W.9 Sri. Kalya Naik to come over to Shivapura village. Myself, C.W.9 and others had gone to the house where the deceased Sri. Galya Naik and the accused no.1 were residing at Shivapura village. A death note written by deceased Sri. Galya Naik was found inside the electric switch board; and another death note written by the deceased Sri. Galya Naik was found behind a mirror in the said house. The accused no.1 and 2 are the responsible for the death of deceased Sri. Galya Naik.

Ex.P.2 and 3 photos are the photos of the dead body of the deceased Sri. Galya Naik. Now I see Ex.P.4 and 5 they are the said death notes. I have given statement before the Police.
