CW.12 – Smt.Sahebee is my wife. CW.13 – Sri.Syed Chand Basha is my son. Deceased Smt.Moula Bee is my daughter. Accused is husband of said Smt.Moula Bee.

About 5 years ago I performed marriage of my said daughter Smt.Moula Bee with the accused in front of my house. After the marriage, my daughter Smt.Moula Bee and the accused were residing at Chittawadigi in the house of the accused. CW.7 – Sri.Driver Mabu Sab is the father and CW.8 – Smt.Ameena is the mother of the accused. CW.7 and CW.8 were also residing along with my daughter Smt.Moula Bee and the accused. CW.9 – Sri.Ismail is the elder brother of the accused and he is residing separately. The accused used to come home drunk and used to ill-treat my daughter Smt.Moula Bee.

About 4 ½ years ago one day, I was on duty as a driver in a tipper lorry belonging to a mining company. At about 07.00 p.m. on that day I

received a phone call from CW.9 – Sri.Ismail. He informed me over phone that my daughter Smt.Moula Bee has got hanged herself and that she was brought to Government Hospital, Hosapete, for treatment. Myself, CW.12 – Smt.Sahebee, CW.13 – Sri.Syed Chand Basha, and CW.16 – Sri.Sardar Khan went to the said hospital. By the time we reached the said hospital my daughter Smt.Moula Bee had died. We learnt that she had hanged herself to a Thole (wooden blog inside the house) with the help of her own vale. I went to Chittawadigi police station and gave my complaint to the said Police. Now I see my said complaint which is now marked as **Ex.P.1** and my signature is now marked as **Ex.P.1(a)**. At the said hospital itself postmortem was conducted on the dead body of my daughter Smt.Moula Bee. Now I see a photo which is the photo of the dead body of my daughter Smt.Moula Bee. The said photo is now marked as **Ex.P.2**. The Police have visited the house of the accused and conducted a mahazar at the place in the said house where my daughter had got herself hanged. Now I see the said mahazar which is now marked as **Ex.P.3**. My signature therein is now marked as **Ex.P.3(a)**. The Police have got taken 2 photos of the said place. Now I see the said photographs which are now marked as **Ex.P.4 and Ex.P.5**. In the said photos, myself and CW.5 and CW.6 are present. The said vale was still on the said wooden blog. The Police have seized the said vale. I can identify the said vale if shown to me. Now I see the said vale which is now marked as **M.O.1** (the M.O.1 is in 3 pieces). The said suicide incident took place within 4 – 5 months from the date of marriage. The accused is responsible for the death of my daughter Smt.Moula Bee.
