The accused is my son. Deceased Smt.Moula Bee is my daughter-in-law. PW.1 – Sri.Kasim Sab is the father of deceased Smt.Moula Bee. CW.8 – Smt.Ameena is my wife. CW.9 – Sri.Ismail is my eldest son.

The marriage of the accused with deceased Smt.Moula Bee took place about 4 years ago in front of the house of PW.1. After the marriage deceased Smt.Moula Bee started residing in our house. In our house, myself, my wife, the accused, and deceased Smt.Moula Bee were residing. The accused was a driver cum cleaner of a lorry belonging to a mining company. Within about 4 months from the date of marriage, deceased Smt.Moula Bee had committed suicide by hanging herself with the help of her vale. On the previous date of the alleged incident myself and my wife had been to Ballari. On the date of incident we came to our house at Chittawadigi in the night. When we returned we entered the house. Deceased Smt.Moula Bee was not to be seen. We searched for her. The accused was sleeping in a room. When we asked him, he said

that deceased Smt.Moula Bee must be inside. When we went to the other room in the said house, we found that the door of the said room was bolted within. We pushed the door and found that deceased Smt.Moula Bee was in hanging position. We felt that she must be still alive. Hence we took her to Government Hospital at Hosapete. The Doctor at the said hospital declared that she was brought dead. I myself telephoned to PW.1 – Sri.Kasim Sab. I do not know the reason for deceased Smt.Moula Bee to commit suicide. M.O.1 – vale which is now shown to me is the one with which deceased Smt.Moula Bee had committed suicide by hanging. I have not given any statement to the Police.

(The learned PP prays for cross examination of this witness on the ground that the witness has given Statement before the I.O. and not ready to depose the truth before the Court. Perused the entire file and the examination-in-chief of this witness. Hence permitted)

Cross Examination by learned PP

It is true that the accused was consuming alcohol and that I had advised him not to consume alcohol. It is true that I used to advise the accused to behave properly with his wife deceased Smt.Moula Bee. It is not true to suggest that the accused used to abuse deceased Smt.Moula Bee by asking her to go and die. It is true that I have given statement before the Police Inspector about the incident.

Cross-examination by Sri.K.V.B. Advocate for accused:-
