Examination-in-chief by: learned P.P.

I do not know C.W.3 and 4. About 5 years ago one day I had been to 100 bed Govt. hospital, Hosapete, for treatment. People had gathered in the said hospital. When I went there, I saw a dead body of a woman aged about 30 to 31 years. I learnt that the name of the deceased is one Mubeenabanu. On the dead body, there was a swelling (contusion) on her forehead, foam was coming out of her nose and mouth, green color mark was there on her neck, hands and thigh. I have seen the said dead body and the said injuries/mark.

I have put my signature on a document at that time. Now I see my signature in the document now shown to me. The inquest mahazar is now marked as Ex.P.1 and my signature as Ex.P.1(a). Now I see photos of the said dead body. The said photos are now marked as Ex.P.2 to 6. In Ex.P.2, the woman by the side of the Police Constable (wearing black color dress and green color nighty) is myself. I learnt that the said woman was murdered.

Cross-examination by Sri. G.V.P., Adv for Accused Nos.1 to 3:-

My husband accompanied me to the hospital on that day. I went to the hospital for treatment to myself. The time was 1.30 p.m. when I reached the hospital. The hospital staff have made me wait as the doctor was not present in the hospital at that time. The staff of the said hospital had told me that they would issue OPD slip after 2.00 p.m.. I have not got obtained OPD slip from the hospital on the said date. I did not meet the doctor on the said date. The witness volunteers that in view of the said Police case I could not meet the doctor on the said date. I did not take any treatment on the said date. I have put my signature at two places. It is true that C.C. camera was fixed in the said hospital. Again I say that I did not observe the C.C. camera in the said hospital.

The Police have recorded regarding the injuries found on the dead body. I can not say the measurement of the green color mark on the neck of the dead body. But, however, the entire neck was appearing in green color. The Police have taken photo of the dead body all around her neck. I have not seen the photo taken by the Police on the back portion of the neck of the dead body. So far also I have not seen the photo taken by the Police on the back portion of the neck of the dead body. The Police have told that the said injuries and marks are the fresh injuries and marks. At the time of inquest mahazar the doctor was not present. I have seen the Police recording the measurements of the injuries and marks. I have not put my signatures on each page of the inquest mahazar. I have not dictated the contents of inquest mahazar. I do not know who dictated the contents of inquest mahazar and who scribed the contents of inquest mahazar. The Police have not taken my photo at the time when I put my signature on the

inquest mahazar. I have not observed as to how many persons have put their signatures on the inquest mahazar. I have not observed as to who all have put their signatures on inquest mahazar before I could put my signature in it. Before I could put my signatures two persons have put their signatures. Subsequent to me putting my signature in Ex.P.1. In my presence Police have recorded the statements of witnesses. It is not true to suggest that I did not visit the hospital on the said date, that the Police did not call me to any place in the said hospital, that I have not seen the dead body in the hospital on the said date, that no photos were taken in my presence on the said date, that no mahazar was conducted in the hospital in my presence, and that the Police have taken my signature on the said document in the Police Station. It is not true to suggest that as per the request and instruction of the Police I am deposing falsely today. It is not true to suggest that though I do not know any fact concerning this case, I am deposing falsely that I learnt that the said woman was murdered. It is not true to suggest that I have not seen the dead body or the injury marks on the dead body in the hospital. The witness volunteers that I am seen in the photo. I have not put my signatures on the photos taken by the Police. The mahazar was done in between 2.30 p.m. to 4.30 p.m.. I do not know the name of the Police who took the photos. I do not know whether it is mentioned in the inquest mahazar regarding taking of photos.

I discontinued my education when I was studying in II year B.Com.. The Police have taken photos with the help of camera. I can not say as to whether the said camera was digital camera. If a photo is taken on any camera the date, time and year of taking the photo would appear on the

photo. It is not true to suggest that though I do not know any fact of this case I am deposing falsely.
