During January 2014 while I was working as F.DA at B.E.O office Hosapete. On 28.01.2014 I was informed to go to Lokayuktha Office by my superiors. On that day at 5 P.M I had been to Hosapete Lokayuktha Office. There Dy.S.P directed me to come at 3.00 A.M on the next day to attend a search warrant. There C.W-3 was also present. On 29.01.2014 at about 4 A.M. Lokayuktha Police took myself and C.W-3 to Appenahalli Thanda situated at Kudligi Taluk, around 6.30 A.M. Police took us to a house situated at Rampura road. Dy.S.P knocked the door and it was opened by the accused. The Dy.S.P explained the situation and shown him search warrant. Now I see it, it is marked as Ex.P- 1. Ex.P- 1(a) is my signature, Ex.P- 1(b) is signature of C.W-3. Ex.P- 1(c) is signature of accused. Then we entered the house. Conducted search procedure. There we found 12,720/- Cash, Silver ornaments, Accused was wearing a gold chain, his wife Annapurna was also wearing gold ornaments. We traced pass book, F.D receipts and some investment details. We have listed all the house hold articles along with gold and silver articles, vehicles. Now I see the said list it is marked as Ex.P- 2. Ex.P- 2(a) is my signature, Ex.P- 2(b) is signature of C.W-3. Ex.P- 2(c) is signature of accused. The listed articles

were handed over to the accused. I can identify the person who was found in that house, witness identifies the accused. Around 2 P.M whole procedure was concluded.

Cross-examination by Sri. L.C.M., advocate for accused

I was informed by Phone, by my superiors. Written permission was not issued to me. In the morning Nagaraj and Manjunath Police Officers were there. C.W-3 also came along with me. There was no prier information about the raiding spot. There were three person in the house. No public were allowed. The North of the house is Rampur road, South Mohanlal's property, East Nagaraj Naik house and at West Khakra Naik's house. The ornaments wearied by the accused and his wife was asked to remove and returned after self evaluation consulting with the accused. Appraiser was not accompanied with us. I don't know what was the price of gold and silver during 2014. It is false to suggest that I have not given information to drawn Panchanama. It was typed in laptop. Printout was taken at the spot. It is false to suggest that Ex.P- 2 is drawn at Police Station. It is false to suggest that I am not aware of recitals of Ex.P- 2. I cannot say the denomination of cash. It is true that the prices of vehicles was approximately fixed. Accused has not revealed the source of purchasing the vehicle. During Panchanama no public were gathered throughout.
