**Examination in Chief by Sri.C.K.N. Advocate for petitioner:-**

My learned Advocate has prepared my examination-in-chief by way of affidavit as per the instructions given by me; and thereafter explained to me the facts noted in the said affidavit. I know the contents of the affidavit filed by me in lieu of my examination-in-chief. The same are true and correct and knowing the same. I have affixed my signature.

R.T.C. in respect of my land in Sy.No.931/1 of Kudligi village of the year 2023-24 is marked as **Ex.P.1**.

I have produced certified copy and notarized copy of Guideline value of my said land as per the Sub-Registrar, Kudligi, for the year 2023-25. After comparing the said two documents, notarized copy is marked as **Ex.P.2** ( Certified copy is returned back).

**Cross-examination by Sri.M.B.R, Adv for Respondent :-**

I am raising Maize crop in my land. Due to drawing of High tension electric wires, the agricultural produces are reduced. I have produced RTC to show that Maize crop is grown in our land.

I have mentioned in my examination-in-chief/affidavit that I am growing Maize crop in my land.

At the time of drawing High tension electric wire, there were Maize crop was there in my land.

I have not produced any document to show that the valuation of my agricultural land is Rs.20,00,000/-.

I have not produced any document to show that, I have sustained Rs.1,00,000/- total loss, due to drawing of High tension electricity wires. It is false to suggest that, since I have not incurred and sustained any loss, so I have not produced the document to that effect.

I have not made any application before the Respondent contending that, I have sustained loss due to damage of crops; damage of land, due to drawing of High tension electric wires. It is false to suggest that, since I have not incurred and sustained any loss, so I have not produced the document to that effect.

I have not conducted any survey of my land to show the extent of the uncultivable land, due to drawing of High tension electric wires.

It is false to suggest that, I have not sustained any loss or incurred any damages either to the crops or my land, so the Respondent is not liable to pay any compensation to me.

I have not produced any documents to show that, bore well was existing in the land; the said bore well was damaged on drawing the High tension electric wires; so I have sustained loss for destruction of trees.

I have received a sum of Rs.1,03,992/- from the respondent.

It is false to suggest that, I have received the said Compensation Amount, without any Protest.

It is false to suggest that, I am not entitled for any Compensation towards diminution of land value, as claimed by me.

It is false to suggest that, I have filed a false case and deposing falsely in this case, in order to have unlawful gains.
