Deceased Kattebennur Hanumantha is my Husband, C.W.6 is my Father-in-law, C.W.4 is my Mother-in-law, C.W.1/P.W.1 is my Brother-in-law, C.W.20/P.W.12 and C.W.21 are my Brothers. I know Accused.

My husband/Kattebennur Hanumantha was an Agriculturist. Accused and my husband/Kattebennur Hanumantha were friends. Accused requested my husband/Kattebennur Hanumantha to avail loan and to give him; accordingly myself and my husband/Kattebennur Hanumantha availed loan from a Sangha/fund and gave Rs.25,000/- to the Accused. The said loan was raised in my name.

Now documents/Loan Documents (Red Ink Page Nos.79 to 101) are shown to the Witness and questioned her to identify the said documents and whether the said documents contain her Signatures. Witness replies that the said documents pertain to the Loan raised in her name; and it

contains her Signature. On identification, all the documents are collectively marked as Ex.P60; and Signature of the Witness for identification, found on the Application at Ink Page No.87 is marked as Ex.P60(a).

Accused used to take my husband/Kattebennur Hanumantha on his Motor-cycle; he has taken so for about one week, prior to the death of my husband/Kattebennur Hanumantha.

About 4 years back, Accused had taken my husband/Kattebennur Hanumantha on his motor-cycle towards Tumbinakere Lake and committed his murder by assaulting him.

Myself and my Parents-in-law had been to the Place where the dead body of my husband/Kattebennur Hanumantha was lying. I have seen the dead body of my husband/Kattebennur Hanumantha; he had sustained assault injuries over his face and all over his body.

Now Positive Photographs/Ex.P2 to Ex.P7 are shown to the Witness and questioned her to identify the same. Witness contends that the said Positive Photographs/Ex.P2 to Ex.P7 pertains to the dead body of her husband/Kattebennur Hanumantha.

Accused has committed the murder of my husband/Kattebennur Hanumantha, since my husband has shown the house of the Accused to the Police, at the time of conducting the Raid, on the house of the Accused.

I have given Statement before Hirehadagali Police.

Cross-examination by Sri. G.V.P., Adv for Accused:-

I am having three Children viz., Roopa, Mamatha and Kamma.

It is true to suggest that, my husband/Kattebennur Hanumantha used to consume Alcohol. It is false to suggest that, my husband was a Non-vegetarian. It is false to suggest that, my husband/Kattebennur Hanumantha was also called as Koli Hanumantha.

I do not know anything about the incident in this Case.

It is false to suggest that, I have affixed my Signatures on the loan papers at my residence. Witness volunteers that she has affixed her Signatures at Harapanahalli.

As soon as I received the Receipt/Cheque for receiving the Loan money, the said Receipt/Cheque was taken by the Accused; and he has withdrawn the said Amount. No any money was received by me. I have not personally seen the Accused withdrawing money from the Receipt/Cheque given to me towards Loan Money. It is false to suggest that, I am deposing falsely that on receipt of the Cheque, the Accused has snatched the said Cheque from me and got it withdrawn and took away the said money, without giving any money to me.

It is false to suggest that, I have not withdrawn any money from my Account, which I have received as a Loan Money; and I am deposing falsely in this Case, at the instance of Hirehadagali Police.

It is false to suggest that, I am deposing falsely that my husband/Kattebennur Hanumantha had shown the house of the Accused to the Police, when the Police had come to Raid his house; and due to the said vengeance, the Accused has committed assault and caused murder upon my husband/Kattebennur Hanumantha.

It is false to suggest that, I am deposing falsely that my husband/Kattebennur Hanumantha has gone with the Accused on his Motor-cycle, for about one week prior to his death.

It is false to suggest that, I have never gone to the Spot, where the dead body of my husband/Kattebennur Hanumantha was lying; and seen the dead body of my husband/Kattebennur Hanumantha, having sustained assault injuries, as contended by me in my Examination-in-chief.

It is false to suggest that, I am deposing falsely that I have given Statement before Hirehadagali Police.
