**Examination-in-chief by: learned P.P.**

I was working as Assistant Engineer in the Office of P.W.D., Sub-Division, Hadagali, since 2003 to 2021.

The Office of the Assistant Executive Engineer, P.W.D., Sub-Division, Hadgali has received requisition from Hirehadagali Police Station to furnish the Sketch of the place, where the dead body of deceased/Kattebennur Hanumantha was found. Accordingly, Assistant Executive Engineer, P.W.D., Sub-Division, Hadgali has instructed me to visit the Spot and give the Sketch of the said Spot.

On 04.10.2019, C.W.39/Siddi Muburak, H.C., had shown the place; accordingly I have prepared the Sketch of the said place and submitted it before the Assistant Executive Engineer, P.W.D., Sub-Division, Hadagali. Now a document/Sketch is shown to the Witness and questioned him to identify the same. Witness contends that he has prepared the said Sketch. On identification, the said Sketch is

marked as Ex.P64 and Signature of the Witness on the Sketch/Ex.P64 is marked as Ex.P64(a).

**Cross-examination by Sri. G.V.P., Adv for Accused:-**

We are preparing the Sketch, as it is, as per the Spot, seen on visit.

In the Sketch/Ex.P64, I have shown the body of a person.

I have prepared the Sketch/Ex.P64 on the Spot; and I have obtained the Signature of Siddi Mubarak, HC/C.W.39 on the Sketch/Ex.P64.

I have prepared Original Sketch in only one copy. It is true to suggest that, the Signature affixed by Siddi Mubarak, H.C./C.W.39 on the Sketch/Ex.P64; the said Sketch is not available in the Court file.

It is false to suggest that, I am deposing falsely that I had gone to the Spot, as shown by Siddi Mubarak, H.C./C.W.39, prepared the Sketch, as per Ex.P64.

Re-examination - **Nil** -.

Court Question : -

When you had visited the Spot, on the said day, whether a dead body was available on the Spot, as shown in the Sketch/Ex.P64 ?

Answer : - No any dead body was available on the Spot, at the time of my visit. Witness volunteers that he has shown the picture of a lying body in the Sketch/Ex.P64, as per the say of Siddi Mubarak, H.C./C.W.39.

**Cross-examination on Court Question by Learned PP – NIL.**

**Cross-examination on Court Question by Sri. G.V.P., Adv for Accused:-**

When I had been to the Spot for inspection, I have not been shown any Positive Photograph of a body lying on the Spot.

I have given Statement before Hirehadagali Police that I have preped the Sketch/Ex.P64, as per the say of Siddi Mubrak, H.C./C.W.39, on the same day when I had visited the Spot. On the day of my visit, I have given the Original Sketch, prepared by me to Hirehadagali Police.
