About 5 years back, Hirehadagali Police have taken my Signatures on some documents.

Now a Seizure Mahazar/Ex.P39 is shown to the Witness and questioned him to identify, whether the said document contains his Signature. Witness answers in the Affirmative. On identification, Signature of the Witness on the Seizure Mahazar/Ex.P39 is marked as Ex.P39(b). Witness volunteers that he do not know the contents of the Seizure Mahazar/Ex.P39; no any material has been seized by Hirehadagali Police, in my presence.

Now M.O.16- Sandisk Pendrive present in the Open Court is shown to the Witness and questioned him to identify the same. Witness fails to identify it.

Now three Positive Photographs/Ex.P40 to Ex.P42 are shown to the Witness and questioned him to identify, whether he is seen in the said Photographs. Witness answers in the Affirmative.

Now C.C.T.V. Footage Positive Photographs marked as Ex.P53 to Ex.P59 are shown to the Witness and questioned him to identify the same. Witness fails to identify those Photographs.

It is false to suggest that, on 10.11.2019, C.W.22/P.W.13 has produced Sandisk Pendrive/M.O.16 before Hirehadagali Police; wherein Hirehadagali Police have seized the said Sandisk Pendrive in my presence as well as in the presence of C.W.12, by drawing the Seizure Mahazar, as per Ex.P39, got clicked Positive Photographs, as per Ex.P40 to Ex.P42; the said Pendrive consists of the C.C.T.V. Footage, the Footage Prints are marked as Ex.P43 to Ex.P59; the said Mahazar proceedings were conducted inbetween 06.00 p.m. to 07.30 p.m. in the evening.

It is false to suggest that, I am deposing falsely in this case, in order to help the Accused persons.
