I know C.W.9/P.W.7 and C.W.1/P.W.1. I know deceased Kattebennur Hanumantha and the Accused, as they are from my Village.

About 4 years back, I have affixed my Signature to the Spot -cum- Seizure Mahazar conducted by Hirehadagali Police, on the spot where the dead body of Kattebennur Hanumantha was found lying.

Now Spot Mahazar/Ex.P8 and Sketch/Ex.P9 are shown to the Witness and questioned him to identify, whether the said documents contain his Signatures. Witness identifies his Signature. On identification, Signature of the Witness on the Spot -cum- Seizure Mahazar/Ex.P8 is marked as Ex.P8(c) and on the Sketch/Ex.P9 is marked as Ex.P9(c).

Now four Positive Photographs/Ex.P10 to Ex.P13 are shown to the Witness and questioned him to identify the same. Witness contends that he is seen in Positive Photographs/Ex.P10 to Ex.P12

and the said Photographs were clicked at the time of conducting the Spot -cum- Seizure Mahazar.

The said spot -cum- Seizure Mahazar was conducted inbetween 02.30 p.m. to 03.30 p.m.

At the time of conducting the Spot -cum- Seizure Mahazar, Hirehadagali Police have seized normal Blood and Blood stained mud. Apart from that I have not seen that Hirehadagali Police have seized any other Articles.

Now M.O.1 to M.O.6 present in the Open Court are shown to the Witness and questioned him to identify the same. Witness fails to identify M.O.1 to M.O.6.

I have not seen whether Hirehadagali Police have seized M.O.1 to M.O.6, at the time of conducting Spot -cum- Seizure Mahazar/Ex.P8.

I have affixed my Signature on the Spot -cum- Seizure Mahazar/Ex.P8 and Sketch/Ex.P9, at the instance of Hirehadagali Police. I do not know the contents of Spot -cum- Seizure Mahazar/Ex.P8 and Sketch/Ex.P9.

It is false to suggest that, I am deposing falsely that Hirehadagali Police have got clicked Positive Photographs, as per Ex.P10 to Ex.P13, at the time of conducting the Spot -cum- Seizure Mahazar/Ex.P8.
