From 19.05.2020 to 06.06.2021, I served as Circle Inspector of Police, Hadagali circle.

On 18.01.2021, I have submitted test report dated 30.10.2019 received by my predecessor in office from CW.43 / PW.25 – Sri.Raghavendra, Scientific Officer, R.F.S.L., Kalaburagi. The said test report is already marked as Ex.P.72. The covering letter dated 18.01.2021 under which I have submitted Ex.P.72 is now marked as **Ex.P.75**. My signature in Ex.P.75 is now marked as **Ex.P.75(a)**.

On 15.03.2021, I have submitted - (i) a lab report dated 25.08.2020 received from F.S.L., Bengaluru, issued by Dr.Kumuda Rani (CW.45); (ii) C.D.R. and C.A.F. certified copies in duplicate pertaining to mobile phone No.8050334951 belonging to CW.19 – Sri.Hurukallu Anand from Nodal Officer of Airtel Company by name Sri.Stanley (CW.46), and (iii) C.D.R.

and C.A.F. certified copies in triplicate pertaining to mobile phone No.8747881102 belonging to CW.1 – Sri.Kattebennur Koteppa from Nodal Officer of Vodafone Company by name Sri.Prakash (CW.47). Said test report dated 25.08.2020 issued by CW.45 – Dr.Kumuda Rani is marked as **Ex.P.76**. The P.F. which was returned along with Ex.P.76 – F.S.L. report (which P.F. was submitted by my predecessor I.O. to F.S.L, Bengaluru, while sending the material objects for scientific examination) is now marked as **Ex.P.77** and my signature in Ex.P.77 is now marked as **Ex.P.77(a)**. C.D.R. and C.A.F. certified copy pertaining to mobile phone No.8747881102 belonging to CW.1 – Sri.Kattebennur Koteppa received from Nodal Officer of Vodafone Company by name Sri.Prakash (CW.47) along with 65B certificate is marked as **Ex.P.78**. C.D.R. and C.A.F. certified copy pertaining to mobile phone No.8050334951 belonging to CW.19 – Sri.Hurukallu Anand received from Nodal Officer of Airtel Company by name Sri.Stanley (CW.46) along with 65B certificate is marked as **Ex.P.79**.

Cross-examination by Sri.G.V.P., Advocate for accused:-

I received the above noted documents openly, but not in closed cover. I have gone through the said documents.

Question:- Can you say as to the information gathered through how many CC cameras are contained in the C.D.R.s marked supra?

Answer:- I can answer but not from my memory but after going through the records.

Question:- Can you say the places in which the said CC cameras were fixed from which the footages are taken while sending the C.D.R.s?

Answer:- I can answer but not from my memory but after going through the records.

All that I have done is I have gone through the above noted documents which were collected by my predecessor Investigating Officer and perused them and listed the said documents and submitted to the Court. I have seen the sealed covers through which the said C.D.R.s were received by my predecessor Investigating Officer. I do not remember the date on which those sealed covers were received by my predecessor Investigating Officer. It is not true to suggest that since the R.F.S.L., Kalaburagi, and F.S.L., Bengaluru, have not sent their reports along with annexures through sealed covers, the said sealed covers are not submitted before this Court. It is true that if any sealed covers are received, the receiving official would put the seal of our office and the signature of the authorized person would be put on such cover and it would be entered in inward register.

Question:- Whether the 65B certificates (referred to supra) contain the name, designation, and full address of the persons who issued them?

Answer:- I can answer but not from my memory but after going through the records.

Again I say that the 65B certificates (referred to supra) contain the name, designation, and full address of the persons who issued them. It is not true to suggest that I have not submitted 65B certificates issued by the

concerned authorities. It is true that in Ex.P.72 I have not put my initials regarding the fact that I have seen the said document. Ex.P.75 is prepared by my then staff by name Sri.Mubarak and thereafter I have perused the contents of the same, put my signature and submitted to the Court. It is true that the C.D. which is part of Ex.P.76 does not bear the signature of the Investigating Officer. It is not true to suggest that I have not submitted the above noted documents to the Court. It is not true to suggest that I am deposing falsely.
