C.W.1/P.W.1 and deceased Kattebennur Hanumantha are my relatives.

I do not know Accused.

About 4 years back, when I had been to Hirehadgali Police Station, our relative/Koteppa S/o Hulugappa/ C.W.1/P.W.1 had come to the said Police Station, wherein he requested me to write a Complaint, as he do not know to write it. As per his request, I have written the Complaint, as per Ex.P1 and have affixed my Signature over it. Witness identifies his Signature on the Complaint/Ex.P1. On identification, Signature of the Witness on the Complaint/Ex.P1 is marked as Ex.P1(b).

I have not informed the Complainant/ C.W.1/P.W.1 from my Mobile Phone to his Mobile Phone that the dead body of his Brother is lying near the Tumbinakere Stream.

I do not know C.W.7 and C.W.16/P.W.2. They have not informed me anything about the facts relating to this Case.

I have not given any Statement before Hirehadgali Police.

I do not remember the contents of the Complaint/Ex.P1.

(The learned PP prays to treat this witness partly hostile. Perused the entire file and the examination-in-chief of this witness. Hence permitted)

Cross Examination by learned PP

It is false to suggest that, on 01.09.2019 when I received the information that dead body of some person is lying near Tumbinakere Stream, I went to the said Spot and revealed that the said Dead Body was of the brother of C.W.1/P.W.1; thereafter I called C.W.1/P.W.1 on his mobile phone and informed that the dead body of his brother is lying near Tumbinakere Stream.

It is false to suggest that, subsequently C.W.7 and C.W.16/P.W.2 informed me that deceased/Kattebennur Hanumanthappa and Accused had been to Kamadhenu Bar at Hirehadagali, for consumption of alcohol, thereafter the Accused on administering alcohol to Kattebennur Hanumanthappa has committed his murder, with the aid of Machu/Lang.

It is false to suggest that, though I am aware of the contents of the Complaint/Ex.P1 written by me, I am deposing falsely that I do not remember them.

It is false to suggest that, I have given Statement before the Hirehadgali Police on 02.09.2019 contending that "ನಾನು ಮೇಲ್ಕಂಡ ವಿಳಾಸದಲ್ಲಿ ... ನೀಡಿರುತ್ತೇನೆ ". For identification, the said Statement is marked as Ex.P17.

It is false to suggest that, I am deposing falsely in this Case, in order to help the Accused.

Cross-examination by Sri. G.V.P., Adv for Accused:-

(Sri.G.V.P. Adv for Accused submits that, Accused has No Cross Examination towards P.W-5. Hence, Cross Examination of P.W-5 by the Accused is taken as 'Nil').
