**Examination in Chief by Sri.C.K.N. Advocate for petitioner:-**

My learned Advocate has prepared my examination-in-chief by way of affidavit as per the instructions given by me; and thereafter explained to me the facts noted in the said affidavit. I know the contents of the affidavit filed by me in lieu of my examination-in-chief. The same are true and correct and knowing the same. I have affixed my signature.

R.T.C. in respect of my land in Sy.No.316 of Belligatta village of the year 2024-25 is marked as **Ex.P.1**.

I have produced certified copy and notarized copy of Guideline value of my said land as per the Sub-Registrar, Kudligi, for the year 2023-25. After comparing the said two documents, notarized copy is marked as **Ex.P.2** ( Certified copy is returned back).

**Cross-examination by Sri.M.B.R, Adv for Respondent :-**

It is true that my land is dry land. It is true that my land depends upon rainfall.

It is not true to suggest that I am deposing falsely that I intended to run poultry farm, fish culture, sheep etc., in my land. I have not produced

any documents regarding my said intention to carry on the said activities in my land.

I am raising Ground nut Crop. Due to drawing of High tension electric wires, I am getting reduced agricultural output.

I have not mentioned in my examination-in-chief/affidavit that I am growing Ground nut Crop in my land.

I do not know if or not Ground nut Crop was standing on my land at the time of drawing High tension electric wire.

I have not produced any document to show that, the valuation of my agricultural land is Rs.10,00,000/-.

I have not produced any document to show that, I have sustained Rs.4,00,000/- loss.

I have not produced any document to show that, I have sustained Rs.15,00,000/- total loss, due to drawing of High tension electricity wires. It is false to suggest that, since I have not incurred and sustained any loss, so I have not produced the document to that effect.

I am aged 56 years. The line was drawn in my land in the year 1992 or 1993. There was no impediment for me to file a case within 3 years from 1992 or 1993. It is not true to suggest that the petition is time barred. It is not true to suggest that since the petition is time barred, the respondent is not liable to pay any compensation to me. It is not true to suggest that I am deposing falsely by filing false case.
