**STATEMENT OF ACCUSED RECORDED U/S 313 Cr.P.C.**

Q.1. Have you heard the evidence lead by complainant in this case?

Q.2. PW 1 has deposed that you had executed a promissory note-Loan agreement on 04.04.2009 acknowledging receipt of Rs. 12,77,800/-. You had paid certain amount to the complainant towards interest. Further you have failed to make regular payment. In a settlement arrived at in the month of March 2021, you had undertaken to return the above said amount and you had received, in all 12 cheques. Out of it you had issued a cheque bearing no. 288715 dated: 26.03.2021 for Rs. 1,04,000/- drawn on Corporation Bank, now merged with Union Bank of India, towards the part payment. What do you say?

Q.3. PW.1 has further deposed that on presentation of said cheque, it was dishonored as "Payees Endorsement required" on 30.03.2021. The complainant intimated the same to you and you had requested to present the cheque again. As such the complainant had presented the cheque again on 15.04.2021. The cheque was dishonored on 16.04.2021 for the same reason. What do you say?

Q.4. PW.1 has further deposed that he has got issued the legal notice to you as per Ex.P.-3 on 04-05-2021 by RPAD. What do you say?
